at all times allowed him; and I confidently believe that the gentlemen on whom the disagreable task of conducting the investigation into the Accounts of the Treasury devolved, fulfilled their duty in the kindest spirit towards Mr. Wallace, and would have been most happy to have received from him more satisfactory explanations than they were fortunate enough to obtain.
