Bill, intituled, "An Act to amend the law respecting Appeals in cases of Summary "Convictions and Returns thereof, by Justices of the Peace in *Upper Canada*."

Bill, intituled, "An Act to amend the Act twenty-ninth *Victoria*, Chapter seven, "respecting works connected with the Defence of the Province."

Bill, intituled, "An Act to amend Chapter fifteen of the Consolidated Statutes for "*Lower Canada*, respecting Public Education."

Also the Legislative Council have agreed to the amendments made by this House to the following Bills, without any amendment:—

Bill, intituled, "An Act to enable *Philip Pearson Harris* to obtain a Patent for a "machine for refining and deodorizing crude Petroleum Oil."

Bill, intituled, "An Act to enable the Honorable *Philip H. Moore*, to obtain a "Patent for the invention of a new method of manufacturing Peat into Coal by process "of steam."

Bill, intituled, "An Act to incorporate the Bank of *London*."

Bill, intituled, "An Act to amend the Charter of the Bank of *Canada*."

Bill, intituled, "An Act to amend chapter twenty-seven of the Consolidated Statutes "for *Lower Canada*, respecting Masters and Servants in the Country Parts."

Also, the Legislative Council have agreed to the amendments made by this House to their amendments to the Bill, intituled, "An Act to amend and consolidate the several "Acts respecting the Assessment of Property in *Upper Canada*."

And also, the Legislative Council have passed the Bill, intituled, "An Act to incor- "porate the Society called *La Caisse d'Epargnes de la Section St. Joseph, de la Société "de Tempérance de Montréal*," with an amendment, to which they desire the concurrence "of this House.
