### MOTHER De SALES

Former Superior of the Ursuline Convent Here Passes Away at Muskegon-A Useful Life.

The Muskegon, Mich., Daily Chronicle, of last Saturday, contained an account of the death of Mother De Sales, Mother Superior of the Ursuline Convent there. Mother De Sales was the youngest sister but one of A. McDonnell, Provincial Land Surveyor, Queen Street. The Chronicle says—"Her illness was so sudden and unexpected that the news of her death comes as a shock to the French people of Muskegon and the many friends of the school of which she was the head.

"For weeks she has been ailing but she was about the academy until within two days of her death. Dr. Geo. L. Le Ferre was called Sunday. Yesterday her condition became so alarming that in the afternoon Dr. F. W. Garber was summoned in consultation.

"It became apparent there was no hope. At 2.30 Fr. D. M. A. Magnan, pastor of St. James, administered the last sacrament. Bishop Rechler, who was notified by telegraph, arrived in the evening and remained at the bedside of Mother Superior until a late hour.

"Mother De Sales was 63 years of age. Her name before prefessing a religious life, was Flora McDonnell. She was born in the county of Huntington, Province of Quebec, March 14, 1841. Her life time of educational work was begun as a public school 14, 1841. Her life time of educational work was begun as a public school teacher. She taught in the public schools of Canada for three or four years before entering the convent. She early was considered a teacher of high standing.

"Entering the Ursuline Convent at Chatham, Ont., from which the Muskegon institution was founded, she

of high standing.

"Entering the Ursuline Convent at Chatham, Ont., from which the Muskegon institution was founded, she took the white veil August 18, 1869. She professed the final vows of sisterhood Nov. 30, 1871.

"Twice before coming to Muskegon Mother De Sales was made superior of the large institution at Chatham. She was first elected Sept. 20, 1879, and served two terms of six years each. In 1888 the sisters came to Michigan to establish a convent and school in Muskegon. Two mother superiors did the work of organization. Then, August 28, 1889, Mother De Sales was sent to take charge of the institution. It proved a missionary work for her even to a greater degree than was expected. The privations and poverty were depressing. Mother De Sales was often heard to say that she asked but one grace—to live to see her sisters in a comfortable home. Finally, last year, the new quarters were accomplished. Few women in this part of the state have accomplished such a work against such odds as did Mother De Sales. She both coamanded admiration for her business ability and she possessed many noble qualities.

The surviving relatives are — Augustine McDonnell, of Chatham, a brother; Dr. Frank McDonnell, of Detroit, nephew; Madam Flora McDonnell, a niece, who is a sister of Sacred Heart, Halifax; Mrs. Jeseph O'Keefe, Chatham; Miss Isabelle McDonnell, of Seaforth, a sister; James O'Keefe, of Denver, Colorado, a nephew; Sister Mary Xavier, of the Ursuline Convent, Muskegon, a neice. The funeral took place on Monday. Solemn High Mass was said at 9,30 o'clock, by the Rev. Bishop Richter, of Grand Rapids, assisted by Father Schrembs, Vicar-General of the diocese; Rev. M. Gallagher, of St. Andrew's Cathedral, Grand Rapids, Master of Ceremonies; Rev. T. L. Whalen, deacon; Fathers Dangelzer and R. W. Brown, assistant deacons.

DEATH BUE TO ACCIDENT.

Insurance Manager Hamilton of London Was Trying to Extract Cartridge From Revelver When Shet.

London, Sept. 28 .- Coroner Mac-

London, Sept. 28.—Coroner MacLaren made further inquiries concerning the shooting of George R.
Hamilton, district manager of the
Imperial Life Insurance Company at
London, and it is now evident that
the first suspicions that the unfortunate man had taken his own life
deliberately were not true.

The doctor removed the bullet from
Hamilton's body and discovered
that, if the shot had been fired with
suicidal intent, then Hamilton had
held the revolver in a position not
only unlikely but almost impossible
in order to inflict the wound. The
bullet had entered to the extreme
left of the body, just at or over the
heart, and had taken a diagonal
course, lodging some inches beneath
the right shoulder. Thus it had taken a slanting course almost directly
across the body.

It has also been made clear that
the revolver with which the fatal
wound was inflicted was not the
property of Hamilton. It came into
his possession through a loan of
money which he made to a friend,
Rev. J. Dagg Scott, ene of the
agents of his company. Hamilton
objected to receiving the revolver.

Was Extracting the Bullets. The police now believe that Hamil-The police now believe that Hamilton was endeavoring to extract the bullets when the revolver was discharged. His stenographer, Miss Wright, who last saw Hamilton, says he remarked to her that he thought he would remove the bullets and he was handling the revolver when she

T. Bradshaw, secretary of the Imperial Life Insurance Company, arrived in the city yesterday morning, together with William Hamilton, formerly of London, a brother of the deceased, and also prominently condeceased, and also prominently nected with the company, and C. J. Burchard, brother-in-law of deceased. Burchard, brother-in-law of deceased.

Mr. Bradshaw made this statement:

"The late Mr. Hamilton had been with our company for six years and during the whole of that time his duties have been performed to our entire satisfaction and his reports have always been sent in promptly.

To our knowledge there is not a single thing that requires evaluate.

single thing that requires explana-tion, or that is out of order. I can say this unhesitatingly." say this unhesitatingly."
The deceased was born in Hibbert
Township, Perth. When 19 years of
age he, in company with A. F. MacLaren, M.P., of Stratford, went to
Colorado, where he remained for four
or five years. On his return he lived
in Winnipeg for probably two years.
Then he removed to Orillia and later
to Toronto, coming thence to this
city some four and a half years ago.
