### A COMMERCIAL FORM.

No. 1 Committee, B. of E., Discuss Its Practicability.

And Refer the Matter to a Special Committee-Teachers Who Want Positions.

No. 1 committee of the School Board met last night. After passing accounts amounting to \$177 84, the members affirmed the clause in Inspector Carson's report recommending that Miss Jennie Overholt, Ailsa Craig, be assigned as student to the Hamilton road kindergarten, and that Miss Grace Johnston, Goderich, be given a similar position at the Rectory street kindergarten.

Tne report stated that if all the public school staff were re-engaged for 1894 there would be two more teachers than necessary. The committee decided that Miss Fleury and Miss McPherson be placed on the substitute staff, with a first lien on any vacancies that may occur.

Said Mr. Carson in his report: In order to establish a commercial form there appears to me two courses open; 1. A competent teacher could be engaged and a class conducted in the vacant room in Princess avenue school. 2. As Princess avenue school is the most central in the city, the high school entrance work in that school could be discontinued and the pupils of the district desiring such a course could attend Talbot street, Waterloo street, Colborne street and Rectory street schools. The pupils of the city wishing to take the commercial form work could take it in the Princess avenue principal's room.

Mr. Griffin objected to the fact of it being necessary for a student to have passed the entrance examination before he could enjoy the benefits of such a course. A boy could then get to work two or three years earlier.

Mr. Alexander held that if pupils who had failed to pass the entrance examination were allowed to attend such a course there would be no incentive for a boy to pass that examination, and the commercial form would then be a refuge for lazy and indifferent boys and girls, who would not take the interest in their entrance examination that they did formerly.

Mr. Craig agreed with the views expressed by Mr. Alexander.

Chairman McRobert objected to the principal of the Princess avenue school being obliged to teach commercial work with his entrance work also. It meant

that one must necessarily be neglected. Mr. Griffin asked if a commercial form could not be established in each of the

public schools. Mr. Carson said it could be carried out, but not successfully. If the class was established there would be rooms to let very soon in the institute, as the teacher that would have to teach the commercial class could not bestow the necessary work on the high school entrance class. Mr. Sanders took the same view as Mr.

Griffin. The matter was ultimately referred to a committee consisting of Messrs. Griffin, Craig, Alexander and Sutherland, who will formulate a scheme and bring it before the
