DIGEST OF THE MINUTES OF SYNOD.

With Forms of Ecclesiastical Processes—
 Statement of principles of Discipline,
 and Historical Introduction.

Such forms of process as are constantly required by Sessions and Presbyteries, will, after careful revision, be inserted. The general principles for the conducting of Discipline in Sessions and Presbyteries will be briefly stated, with a reference to the best authorities. A historical introduction will be given, tracing the rise and progress of the Church, and defining its present position.
