# (From the Boston Journa'.) THE LABORS ENDED.

The Mixed Commission on British and American Claims, appointed under the twelfth article of the Treaty of Washington, which has been in session since the third day of June last, has adjourned, having mode its final awards and concluded its business one day in advance of the time fixed by the treaty; two years from the date of its first meeting in Washington, on the 26th of September, 1871.

## THE OBJECT OF THIS COMMISSION.

as defined by the articles of the treaty referred t, was to hear and decide all claims on the part of the corporations, companies of pivate individuals, critzens of the United States, against Great Britain; or subjects of Her Britannic Mejesty against the Government of the United States, on account of acts committed by the Government of either country against citizens or subjects of the other, between the 12th day of April, 1861 and the 9th day of April, 1865, not being claims growing out of the acts of vessels referred to in the first article of this treaty commonds known as Alabama Claims, adjusted at Geneva.

### THE COMPOSITION OF THE COMMISSION.

The Treaty of Washington provided for three commissioners; one to be named by the President of the United States, one by Her Broannie M. j stv. and third the by the President of the United States and Her Britannic Majesty conjuntly. The Pasalem nomed don. James S. The British Government was further represented on the Commission by Henry Hosard, Esq., or the Boush Legation of W shington, who acted in the capacity or agent, and by Jones L. Culisle, Esq., or Washington, as counsed Hom. Robort S. Hole of New York, was app unted agent an Propused for the United States. Thomas C. Cox, of George town D Calias acted as Secretary of the Commission, Judge Hile was assisted by E. L. Scinton sen of ex Secretary Stanton, and Gen. H. B. Titus, of New Hampshire, who was employed particularly in Certain important dises in Arkansas and Louisiana, known as the Os band raid cases.

## THE CHARACTER OF THE CLAIMS

which have been passed upon by this Commission is second only in importance to those which were presented to the Triburant Geneva. The number of claims presented by the subjects of the Britannic M jesty against the Government of the United States, was four hun-red and seventy eight, amounting in the aggregate to about ninety five millions of dollars including interest. There were claims presented on behalf of citizens of the United States against the Bt tannic Mejecty to the number of mnettern as ounting in all to about one million del-

Of the claims of American citizens against Her Britannic Majesty, thirteen grow out of the St. Alban's raid and the capture of the Philo Pursons on Lake Eric; feur claims were for the detention at Calcutta of vessels louded with sultpetro. Some of these claims were brought by citizens of Boston and presented by F. V. Bulch Esquareting as attorney. The detention of vessels occurred immediately after the receipt of the intelligence of the Trent after, and when wer with Great Britain was hourly expected. Of the two remaining claims, one was for an improvement in fire arms, which had been adopted and used by the British Government and for the expulsion from Sin Juan of an American citizen by the British Government, and consequent loss of a lime quarry.

The claims which were presented on be half of subjects of Her Britanno Majesty against the Government of the United States were of every conceivable character, from the loss of old clothes stolen by Sherman's bummers to a quicksilver mine in Santa Clara County, California, valued at \$14.8-0000, from which the claimants. Berron, Forbes & Co., were ejected by the United States authorities.

The intermediate claims included dama ges orising out of outure, detention, and condemuation of vessels as prizes during the war, the appropriation by the United States Government of their cargoes, and also of quartermaster's and commissary stores in the Southern States during the rebellion, the destruction of property by rebel forces, the alleged uni-wful arrest and imprisonment of British subjects, claims on confederate bonds, claims for dunages in consequence of the en icim on al legal tender act, by which British creditors were compell ed to accept greenoacks in hen of gold in ettlement of claims against American citizens and corporations. These and a hundred other claims of similar character were pressor it on the attention of the Commisa'0n.

## THE WORK OF THE COMMISSION

Up in plassing awards upon these claims his been one of insuperable labor. Each climant has been allowed every opportunity or the establi-himent of his claim. As a consequence, an immense mass of testimony has been taken, and in several indvidu. cases testim by covering thousands of oc two pages has been printed. l'estanony has been taken in nearly, if not every. State and Territory in the United States in all the British Provinces of North America, in Mexico, England, Ireland and Soutand and ever in Egypt. In the taking of the testimony the clamants and their respec tive governments have been represented by counsel who have been allowed the logest lanule in the representation of their several Cases.

## THE AWARDS OF THE COMMISSION.

The existence of this Commission has been patent to only a small portion of the reading public, and yet their action has been watched with interest by the claiminuts on both sides of the Atlantic. Very fittle has been said about this Commission, who have pursued their labors in Newport, at the residence of Mr. King, since the 10th of May list. The amount of printing involved in the work of the Commission is in mease the presses of Washington, Biston, New York, Charleston, S. C., having been employed in the reproduction of the testimony for the use of the Commission and for preservation.

In making up their awards the members

of the Commission are supposed to have been governed by a spirit of equity and a desire to preserve the harmonious relations which exist between the two nations whose interests were involved in the controversy.

#### WHAT ENGLAND BLOSIVES.

The award of the Commission in the case of subjects of Her Britannic Majesty against the Government of the United States numbered one hundred and nineteen, and amounted to one million nine bundred and twenty nine thousand and nineteen dollars, or about two per cent. of the smount claimed.

#### AMERICANS ORT NOTHING.

On the other hand, the claims of the American citizens against the Government of Great Britain are rejected on the principles of international law decided at Geneva, as it did not appear that the Government of Great Britain had not exercised due diligence to prevent these incursions from her territory across the Lorder.

#### THE DECISION PARAL

The decision of this Commission is tind in every case that has been brought before it. The final award of the amount which the United States must pay on account of all these claims, has been signed in duplicate, and a copy will be immediately transmitted to both Governments. This sum, by the terms of the Treaty, must be paid within one year from the date of this fin daward. An appropriation for this purpose will of course be made by the next Congress.

### MINOR PETABLE.

Each Government pays its own Commissioner agent and counsel A all other expenses are defrayed by the two governments in equal materies, except that 5 per cent, of the amount of this find award is to be deducted on account of contingent expenses. The interest in the proceedings of the Commission has apparently been amined to the claimants who have appear al helore it.

## A SUBJECT FOR CONG ARTHARDS.

The general public his known little in regard to it, yet considering the magnitude of the interests at stake in the consideration and final decision of enormous caims against our government, prosecuted by the Government of Great Britam in behalf of her subjects, many of whom had long been residents of this country, mostly in the States lately in rebellion, involving questions of military and maritime as well as international law, these proceedings are truly of great national importance, and that so small a percentage of the claims so ably and persistently prosecuted has finally been allewed is indeed a matter of congrutalation as to each and all of those clams embraced in the Treaty of Washington. The decision has been in our favour in the Alabama claims at Geneva, in the fisheries, in the navigation of the St. Lawrence, and of lakes and rivers connected with it in the chain to the Island of San Juan, by award of the Emperor of Germany, and now finally m an award of but two per cent, of the amount of claims against our Government by citizens of Great Britain, on account of damages resulting from any and all acts done during the war.

## THE FINALE.
