4. The more important and specific instructions issued in this connection to census commissioners are as follows:-

Appointment of enumerators.—After proper enumeration sub-districts have been established and approved by the Bureau of Statistics it will be your duty to select a suitable person in each sub-district to perform the actual work of enumeration. This is a very important duty and you must exercise the greatest possible care to secure Your own success as competent persons. commissioner and the success and value of the census as a whole are absolutely dependent upon the thoroughness, accuracy and promptness with which the enumerators perform their duties. The Book of Instructions clearly sets forth the duties and qualifications of the enumerators, while the specimen schedules of population and agriculture and the examination papers relating thereto should enable you to select only such persons as have the capacity for efficient service. You are particularly enjoined to reject all applicants who are unable to pass the examination test satisfactorily and in such cases you are authorized to immediately fill the vacancy.
