The requirements for the position of Director, Community Affairs are: A thorough knowledge of the Indian and Eskimo Affairs Program gained through a number of years' experience at senior levels of responsibility in the Department; A proven ability to plan, develop and implement policies and programs which ensure a political, economic and social self-determination amongst the Indian and Eskimo people; A demonstrated ability to communicate effectively with and gain the respect of native people, other government officials at a senior level, and members of the public.

3. Mr. McGilp has had extensive experience in Indian and Eskimo affairs, both in the Territories and in the Provinces, and has acquired a sound understanding of the social. economic and educational needs of the Indian and Eskimo people. He has also proven, in a number of assignments at increasing levels of responsibilities, his managerial and representational capabilities.
