## AIR TRANSPORT

MANITOBA BILL IMPOSING TAX ON OVERFLIGHTS ACROSS PROVINCE—SUGGESTED EXAMINATION OF CONSTITUTIONALITY

Mr. E. B. Osler (Winnipeg South Centre): Mr. Speaker, this question is directed to the Minister of Transport and it also concerns airlines. The Manitoba Government's Bill 21 does several things, but in view of the implications this measure appears to have for the free operation of mainline airlines and the development of northern transportation, as well as weakening the federal government's regional airline policy for Manitoba and the northwest, does the minister intend to have the constitutional legality of this legislation examined?

Mr. Speaker: Order, please. This is clearly not a supplementary question. I find it difficult to allow the hon. member to ask a question when he seeks the floor on what is allegedly a supplementary and it is clearly not so. At the same time the hon. member has taken the time of the House to ask the question, and the minister might be allowed to reply.

## **INDIAN AFFAIRS**

FRIENDSHIP CENTRES—DEPARTMENTAL RESPONSIBILITY FOR GRANTS

Mr. Paul Yewchuk (Athabasca): Mr. Speaker, I want to direct this question to the Prime Minister. Can he indicate whether a decision has yet been made as to which department, that of the Secretary of State or that of the Minister of Indian Affairs and Northern Development, is responsible for grants to Indian friendship centres?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, as a general principle both departments have authority to give grants to assist Indians and other groups of citizens to pursue their studies and representations. That is the principle, but if the hon. member has a question relating to any specific centre I could find out which of the two departments is in fact dealing with it.
