## INCOME TAX

ALLEGED GOVERNMENT SPONSORED BROADCAST EXPLAINING FORMS—NUMBER OF COMPLAINTS

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, my question is directed to the Minister of National Revenue. I should like to ask him whether the government intends to have further broadcasts on the CBC to explain the unexplainable in connection with the income tax form?

Hon. Robert Stanbury (Minister of National Revenue): First, Mr. Speaker, may I thank the right hon. gentleman for the honour of responding to his question on this happy day for him and for all of us. I think the premise of his question is mistaken in that the government has not sponsored any such broadcast. Perhaps he is referring to the CBC "Tax Test" last Friday evening. This is not the first year there has been such a national tax test, and I presume it will not be the last. It was a CBC program not paid for in any way by the Department of National Revenue. I might tell the right hon. gentleman that so far the tax returns are coming in very well and the error rate is about 40 per cent below that of last year.

Some hon. Members: Hear, hear!

Mr. Diefenbaker: Mr. Speaker, there are two kinds of falsehoods, ordinary falsehoods and statistics. The hon. gentleman has established a statistic without telling us how many have sent in their returns. Has he not a multitude of letters of complaint concerning the maelstrom of difficulties in which Canadian taxpayers find themselves by reason of the stupidity of the government in respect of its questions?

**Mr. Stanbury:** Mr. Speaker, I must say there were a number of complaints, particularly before the forms were distributed, stimulated partly by fear tactics on the part of the opposition.

Some hon. Members: Shame!

**Mr. Stanbury:** However, in recent weeks and days the correspondence has been quite the contrary, and I am glad to say—

Mr. Speaker: Order, please.

**Mr. Stanbury:** —that the return rate is about the same as the year before.

Mr. Speaker: Order, please. I ask the co-operation of hon. members to limit the number of supplementaries between now and the end of the question period. Order, please. I believe the Chair cannot allow supplementaries. There are three minutes left before the end of the question period. The hon. member for Cape Breton-East Richmond rises on a point of order.

Mr. MacInnis (Cape Breton-East Richmond): Mr. Speaker, I rise on a point of order to inform the minister in just what bad shape he is. He sent me a request for assistance in respect of his tax form.
