National Defence: membership in private clubs paid from public funds for cabinet ministers, deputy ministers, assistant deputy ministers etc. as posed by this question is nil. Club membership may be reimbursed where an identifiable program benefit exists. Stipulations are as follows:

The member will bear a minimum personal share equal to the lowest rate of annual membership in a regular force mess, located in Ottawa, (currently \$168.00). In addition, if facilities for golf, tennis, curling, etc., are included in the membership, an additional personal share equal to a single regular membership in the Hylands Club, located at CFB Uplands (currently \$200.00 per annum), will be assessed.
