NATIONAL SALES TAX

Riis (Kamloops—Shuswap): Mr. Speaker, every Canadian from coast to coast should be warned that in 1989 the Prime Minister (Mr. Mulroney) is going to launch the biggest, most massive tax attack in Canadian history. TREATMENT BY JOURNALISTS

REGIONAL ECONOMIC DEVELOPMENT

REQUEST THAT OUÉBEC GET ITS FAIR SHARE

Mr. Jean-Claude Malépart (Montreal—Sainte-Marie): Mr. Speaker, I was glad to see that after his meetings with the Prime Minister of Canada (Mr. Mulroney) and the Leader of the Official Opposition (Mr. Turner) and future Prime Minister of Canada, my friend Robert Bourassa admitted, for the first time, that Quebec had been poorly treated under a Conservative Government. On the basis of my figures for regional development, he admitted Quebec had only received \$590 million, while Western Canada and the Atlantic Provinces received \$2 billion.

Mr. Speaker, there are 10 major issues involving Quebec which demonstrate how unfairly it is being treated by this Tory Government.
