MOTION TO ADJOURN UNDER S. O. 52**MEECH LAKE ACCORD**

Miss Deborah Grey (Beaver River): Mr. Speaker, pursuant to Standing Order 52, I ask leave to move a motion that the House adjourn to discuss a matter of utmost urgency and importance, namely the constitutional crisis which is building and facing Canada.

There is less than one month remaining for expiration or ratification of the Meech Lake Accord. With a great many threats and predictions of dire consequences that may face Canada on June 24, 1990, I believe that there is need for this House to debate this constitutional dilemma rather than to remain silent.

SPEAKER'S RULING

Mr. Speaker: The hon. member for Beaver River has applied under Standing Order 52 for an emergency debate on a matter which I am sure all members of this House agree is a very important one.

However I must point out that the matter is being raised on a daily basis. The hon. member has another course to follow by which she could debate the matter.

As a consequence, today I am not inclined to grant her application. It has nothing to do with whether or not the matter is serious. We all know it is serious. At this time, and I say at this time, I think it would be inappropriate.

I thank the hon. member for giving me notice, and I thank her for her intervention.
