Mitchell*, \$152 ; Mr. *Labrosse*, \$376 ; Mr. *Rykert*, \$128, for the year ending 30th June, 1885.

48. *Resolved*, That a sum not exceeding Five hundred and thirty-five dollars be granted to Her Majesty, to pay *John Page*, Chief Engineer of Canals, for services as sole Arbitrator in the case of *F. B. McNamee & Company*, Contractors for Section 34, *Welland* Canal, for the year ending 30th June, 1885.

49. *Resolved*, That a sum not exceeding Twenty-five thousand dollars be granted to Her Majesty, to provide for construction of a Waste Weir at *Dunnsville*, *Welland* Canal, for the year ending 30th June, 1885.

50. *Resolved*, That a sum not exceeding Two thousand dollars be granted to Her Majesty, to defray expenses connected with *Boularderie* Wharf, *Nova Scotia*, for the year ending 30th June, 1885.

51. *Resolved*, That a sum not exceeding Seventeen thousand dollars be granted to Her Majesty, to defray the following expenses in connection with Public Works, viz. :—*Owen Sound*, \$10,000 ; *Collingwood* Harbour, \$5,000 ; *Meaford* Harbour, \$2,000, for the year ending 30th June, 1885.
