Londonderry Br.-Night.

FRIDAY, JULY 5, 1889.

We were very pleased to notice by the *Annapolis Spectator* that the town of Annapolis had awarded the contract for water pipe to the Londonderry Iron Company. There were several tenders received. The old country, the United States and Canada competed for this contract. In fact in addition to the tender from the Z. I. C. two other tenders were received from Nova Scotia. But our industry's offer fell below them all. The Londonderry Iron Company is to be congratulated, that in so short a time since the establishment of this branch of its industry, it can place upon the market a superior article, at a cheaper price than the same article can be obtained from old established firms in Glasgow and the United States. Those purchasing should also feel pleased that they can do so much better by patronizing a home industry. That those pipes are of a superior quality cannot be disputed. They are all submitted to a very high test before they leave the shipper's hands—a much higher test than is usually required by purchasers, so those who buy from this company can rest assured that they are getting a good article—one that has been thoroughly tested. We would recommend other towns desiring pipes to do as Annapolis has done, and buy them from the Londonderry Iron Company, and thus save money, as well as secure a splendid article.

The manufacture of pipe in Acadia Mines is only of a recent date. A little over a year ago the pipe foundry began work, and it is likely to become quite an important branch of the iron industry in this place. The company displayed a great deal of enterprise in adding this department to their extensive works, and we trust they will meet with the greatest success, which they richly deserve. With good material at hand, and with the best available facilities for manufacturing it into pipe there seem to be good ground for predicting the greatest prosperity in this work.

Progress at Londonderry Station.

Twenty-two years ago the efforts of the patriotic fathers of confederation culminated in the uniting of the then scattered provinces of British North America. Today, many of those men sleep beneath the daisy deckled sod, of this, their native land, but the work they commenced sleeps not. For twenty-two years these men's noble efforts have been sleeping an annual page of united Canadian History, on each page is recorded progress and prosperity. It tells of united action, it records the building of railways, the developing of our magnificent mineral resources, the settling to the north of other lands the riches of our forest. Villages and towns have sprung up, as by magic, the tall chimneys of hundred roof factories send the hum of machinery, has dispelled nature's solitude of twenty-two years

ago. How truly *Longfellow's* portents those men's lives and efforts in those beautiful lines:

"Lines of great men, all remind us,
We should make our lives sublime,
And in parting leave behind us
Footprints on the sands of time."

Ours is yet an unfinished work. We must leave our foot prints, not those of the sluggard, but those of the patriotic men. This place is one of the many that is springing, so to speak, out of nothing. Twenty-two years ago this place was only a barren waste land, with no visible signs of human life, and no doubt it would have remained such had Confederation not taken place, but upon the building of the Intercolonial Railway it became the receiving and shipping place by rail of Acadia Mines, Great Village, etc. But a new era is dawning upon it—it is on the eve of becoming a manufacturing centre. The Londonderry woodworking Company, with a capital of \$40,000, is commencing to erect a building of no small dimension in which they will manufacture all kinds of builders supplies. Their machinery will be run by a 40 horse power engine. A siding has been located to the factory site. Thomas Purdy, who formerly did a lumbering and manufacturing business at Westchester, is to be manager by this time. The company expect to have the factory in operation by the first of August. Mr. Samuel Lindsay formerly of Great Village, has erected a fine large house—it is his intention to run a first class house of entertainment. He will also deal largely in agricultural implements. Several new and handsome houses are in course of erection, and many of the old houses are being repaired, in order to accommodate tenants, who are daily coming. Thomas Chisholm has also erected a carriage factory. Two new stores are in operation namely, Alonzo Dill and Daniel Giddens. Happy Thought Lodge I. O. G. T. own a very tidy and well furnished hall. The Bass River Furniture factory have warehouses at this station. Altogether Londonderry is fast going ahead.

THE SENTENCE.

Dr. Cronin's Death Ordered By The Grand Jury.
A Member of the Order Has Revoked the Plot.

Several Necks Likely to Be Broken As a Result.

State's Attorney Longenecker had just raised the window curtain in his office the other morning, when he heard a knock at the door. He paid no attention to it, supposing it was some reporter. There is a spring on the door of the attorney's door and you can't go in unless you have a key. The man outside turned the knob, but he didn't go in. The man inside leaned back in his chair and laughed.

Again the man knocked, and he kept on knocking until the state's attorney opened the door and asked, "Well, what do you want?" He was admitted, and gave the state's attorney more facts about the conspiracy to murder Dr. Cronin than has heretofore been told. Several days ago the state's attorney was convinced that the conspiracy was hatched in camp 20, and that Dr. Cronin was tried as a British spy by that camp. He was convicted upon false and manufactured evidence, the penalty was death and certain members of the camp were assigned to the work. Three members of camp 20 are now under arrest, another is being hunted, and at least half a dozen are under surveillance.

The state's attorney refused to divulge the name of his caller. When driven into a corner, he admitted that the man who visited him gave him some important information in regard to Dr. Cronin's death trial.

From a reliable source it was learned that the informant was a Canadian-Gael man, an ex-member of camp 20. So improved was the state's attorney with the man's story that as soon as he left Detective Palmer was sent out to bring in John F. Beggs, senior guardian of camp 20. At 6 o'clock Palmer returned and said that he could not find Beggs.

"What did you want to see Beggs for?" the state's attorney was asked by a Globe reporter. "Well, I just wanted to ask him a few questions."

"I should think that Beggs would have told all he knew about the case by this time."

"If Beggs opened up and told us all he knew," said the state's attorney, "we wouldn't have any trouble in getting at the bottom of the conspiracy originated in camp 20. I'll be honest with you, therefore, I don't say that all the members of camp 20 had a hand in it, but it's the inner circle of that camp who could take the lead."

John F. Beggs was on friendly terms with Dr. Cronin.

"Doesn't Palmer usually bring a man when he goes after him?" "Yes."

"Well, why didn't he bring in Beggs?"

"He said he couldn't find him."

"You don't think he's left the city, do you?"

"I don't think he has, but such a thing is possible. Palmer has been looking for him all day and it's rather queer that he can't be found. Perhaps they'll bring him in to night."

"Did your mysterious visitor this morning give you any pointer about Beggs?"

The state's attorney didn't hear the question, at any rate he made no answer.

A few days after the finding of Dr. Cronin's body Judge Longenecker received an anonymous communication giving the details of Dr. Cronin's death trial as a British spy. Altogether the state's attorney has received over one hundred letters regarding the case, and he paid but little attention to this particular letter at first. In the light of recent developments he has become convinced that the murder was plotted in camp 20, and that at least eight or ten members of that camp knew that Cronin was to be done away with. Not more than three, perhaps, were at the Carleton cottage on the night of the murder. Burke was one, Conroy the other and the third man was one who knew the lay of the land.

The state's attorney is determined to get at the bottom of the case, and will summon every member of camp 20 before the grand jury. Crockett, Ill., June 30.—Martin Goodrich, Patrick Conroy and John Burke were indicted this afternoon for the murder of Dr. H. Cronin. The participation of Alexander Sullivan in the crime will be a matter of investigation for the next grand jury, which is to be impanelled on Monday.

With the exception of Conroy and Burke the persons indicted are to be one of the Williams brothers, and Kuntze is supposed to be the man who drove the victim to his
