CARVELL WAS NOT TO BE CAUGHT

(St. John Times-Star)

Whoever has read any of the comments of the Standard, concerning Mr. Carvell and Lt. Col. Bullock, should read the statements of Mr. Carvell and Mr. Markey in today's Times. There has seldom been a finer example of placing the shoe on the other foot. It is now the duty of the doughty lieutenant-colonel to explain his relations with Rogers, the man who was sent about his business by Mr. Carvell. Mr. Carvell makes it perfectly clear that Rogers was not only in touch with Lt. Col. Bullock, but with German bankers in New York. What was the relation between Bullock and Rogers? The latter had one explanation of his conduct for Mr. Carvell and another for Mr. Markey. He never hinted to them that the alleged documents which were to involve Sir Sam Hughes in grave scandals would have to be stolen, nor did they connive at the theft of any documents. They were not after stolen evidence. They took the measure of Rogers and of Bullock, and declined to respond to the appeals of the former for funds.

It would have been quite an artful stroke if Mr. Carvell could have been involved in some sort of shady transaction at a time when he was bringing out evidence to prove that the "guide, counsellor and friend" of Sir Sam Hughes was partaking of a million dollars rake-off on the fuse contracts. That would have helped to distract public attention from the doings of Col. J. Wesley Allison. Mr. Carvell directs attention to the fact that almost immediately after the Bullock interview was published in Ottawa Bullock was promoted and made a lieutenant-colonel, and it was also made possible for him to come to St. John at public expense and furnish the Standard with the Rogers affidavits, designed by an alien to blacken the reputation of a member of the Canadian parliament who at the outbreak of the war offered to recruit a unit and go with it overseas.

The plot, by whomsoever conceived, has failed. Mr. Carvell was not consorting with Germans in New York. He was not trying to secure stolen evidence. Somebody else was, trying to "get" Mr. Carvell, and the public will have no difficulty in discerning the reason. Mr. Carvell was lifting the lid, and if there is anything the profiteers do not wish to have done it is that very thing. As an American citizen Lt. Col. Bullock should have kept his nose out of political affairs in Canada. Perhaps he does not think so, for he went in a major and came out a lieutenant-colonel, with the privilege of spending the summer in the delightful climate of the maritime provinces; but Sir Sam Hughes will presently discover that the people have views of their own concerning this whole discreditable business.

Death at Edmundston

Thaddeus Hebert, proprietor of the Windsor Hotel in Edmundston, died Wednesday night as the result of injuries sustained in an automobile accident Tuesday evening. He was driving his car alone on one of the streets in Edmundston, when he collided with another car, driven by Joseph Michaud. He was thrown into the road and sustained internal injuries. He was sixty-four years of age and a well known and respected citizen of Edmundston, where he was in the hotel business for the past twenty-five years.

LIEUT. REID ARRIVES

There was much rejoicing among the family and friends of Mr. and Mrs. John H. Reid yesterday when their son, Lieut. Harvey T. Reid, stepped off the train looking hearty and strong. Wounded on Easter day he was given a few months to recuperate and was granted the privilege of visiting Canada.

Lieut. Reid, it will be remembered, was valedictorian of the class of 1913 at Acadia, and was awarded a Rhodes scholarship at Oxford University. While at Oxford and before the war he was attached to the King Edward's Horse regiment and qualified as a lieutenant. At the outbreak of hostilities he was called to arms and has been almost a full year on active service. His wound was from a piece of shrapnel striking the chest and was not considered dangerous. The enforced rest will doubtless be much enjoyed, and as much appreciated by his family and many friends as by himself.

By a stupid error Lieut. Reid was last week reported by a St. John paper to have died of his wound, but he landed quite safe and had the pleasure (?) of reading his own obituary.

Judgments Given

Judge McKeown has given judgment in several cases of local interest. In the case of McCain Produce Co. vs. Atlantic Hay Co., for hay sold and delivered, the plaintiffs were awarded \$2,300. W. P. Jones, K. C., was counsel for plaintiff and J. C. Hartley, K. C., for defendant.

The case of J. Albert Hayden vs. R. W. Cameron was an action for trespass, the point being to try the title to certain land at Highgate. Judgment was rendered in favor of the defendant Cameron. J. C. Hartley was counsel for the plaintiff and M. L. Hayward for the defendant.

Judgment in the case of Thomas Pankhurst who sued Fred Smith for the loss of his hand while at work in his mill early in the spring is still reserved.

Why Yankees Join

Three Americans, college men, recently joined the 5th Pioneers Battalion at Montreal. When asked why it was they joined one of the number said that this was a war of principles, right against wrong, the weak against the strong, and every true hearted American, he said, should join in the fight. He also said that when the United States was in the throes of a civil war over 50,000 Canadians enlisted under the banner of the North to fight for liberty and this was the first opportunity that Americans had had to repay the debt.

R. W. RICHARDSON KILLED IN WOODS

The village was shocked on Monday to hear of the death of R. Willoughby Richardson which occurred that morning at Patten, Me., where he was living. At this writing no particulars have reached The Observer further than that he was struck and instantly killed by a falling tree, presumably in the woods. He had of late been engaged in contracting for pulpwood and had business connections with a number of men in this vicinity.

Mr. Richardson was a native of this parish, and up to a few years ago spent nearly all his life here. He was one of the finest men the county has produced. He was kind; he was honest. Always he displayed a progressive spirit and had great hope of seeing Hartland blossom into a real town. He erected more buildings in the village than any other man. He built and operated for several years the wood-working factory, and was engaged for a long time in general store keeping. At his sudden taking away he was still an active man about 65 years of age. Hartland friends had a visit from him only two weeks ago.

Mr. Richardson leaves a wife, whose girlhood home was in Richmond, Que., and a son, Chester G., of Patten, and a married daughter, Mrs. J. D. Shaw of Hartland is a sister. F. Richardson of Lower Brighton and Geo. W. Richardson of Fort Fairfield are brothers. Conductors Charles Taylor of Presque Isle and L. A. W. Taylor of Boston are brothers.

Lee Dyer Not Dead

Unfortunately The Observer printed an untrue item last week in which it announced that Lee Dyer of Howard Brook had died of wounds. No such word has been received, or sent out by the military authorities. The rumor came through what has proved to be an unauthentic source, and the editor discovered the error in time to inform the relatives in advance of the arrival of the paper. Too much care can not be taken to prevent the spread of false reports such as this, which cause heartache as cruel as if true. The St. John Standard erred similarly last week and announced the death of Lieut. H. T. Reid, but he arrived home quite safe a few days afterward.

Lee Dyer has been wounded, but it is hoped not seriously. Clifford Dickinson, son of H. L. Dickinson of Windsor has also been wounded by rifle shot in the leg.
