

LIBERAL PREMIER'S SUPPORTERS IN SASKATCHEWAN GOVERNMENT WILL NUMBER AT LEAST 45

Martin Expresses Himself as Well Satisfied With Result — Was Thoroughly Confident That His Administration Would Be Returned—Heaviest Vote Ever Cast in the Province.

Regina, June 10.—Saskatchewan decided yesterday not to experiment with group government, and returned to office for another term the administration headed by Hon. W. H. Martin, giving him a majority less sweeping than the one which followed his leadership during the last legislature, but sufficiently large to make him independent of all opposition alignments.

Government supporters will number about 45 in the legislature of 63, when the three deferred elections have been held, in the view of political authorities. The Morning Leader's latest figures are: Government 41, Independent 11, Conservative 2, Labor 1, doubtful 5. This list includes among the doubtful constituencies, Redberry, where Hon. George Langley is 172 down to George Cockburn, Independent, with two polls to be heard from. The political prophets of the Government were surprised at the threatened defeat of the minister of municipal affairs and

declared that complete returns would show his election.

The election in Tisdale is to be held June 23. Elections in Cumberland and Isla-la-Grosse, the other deferred seats, are not set.

The vote yesterday was the heaviest cast in the history of the province, and Premier Martin's total in Regina of more than 7,000 is the largest vote ever cast in Saskatchewan for a legislative candidate.

Hon. J. A. Maharg, elected by acclamation for Moose, has not yet been assigned to a portfolio. There were reports of a rearrangement of the cabinet, by which Mr. Maharg, who is president of the Saskatchewan Grain Growers' Association, might become minister of agriculture. Premier Martin issued a statement last night in which he said the result of the elections was very satisfactory, "and not altogether unexpected." The vote, he considered, was a "gratifying endorsement of the policy of the Government."

That laxity is shown in the enforcement of statutes governing habitation of laundries was contended by Roy Williams, addressing the Kiwanis Club at its weekly luncheon at the Teumess House today.

"There is a law which states that there shall be no sleeping or eating on the premises, but the various laundries of the city who sleep right on the floor while many of them eat in their laundries," stated the speaker.

"In the province of Ontario," he continued, "statistics show that Chinese laundries are being operated to the number of 1,700, which do a weekly business of a quarter of a million dollars, and deprive approximately some 6,000 white girls of employment. I ask you how much support the Chinese laundryman is giving the country?"

The speaker declared the fact that Chinese are brought into Canada under the guidance of the various tongs, and these men already under contract before their arrival compelled to work out their allotment at a very low scale of wages.

Hired "Ghosts" to Frighten Husband But They Killed Him Instead, Claims Woman

New York, June 10.—Dan F. Kaber, wealthy Lakewood publisher, met death after attacking two foreigners engaged by Mrs. Kaber to pose as spirits and frighten him into a better attitude toward her, according to a statement which the New York Evening World today says Chief of Police Christensen obtained from Mrs. Kaber here.

The newspaper quotes Chief Christensen as saying that Mrs. Kaber had consulted a woman medium for advice as to how to change her husband's attitude toward her.

The publisher's surly manner after an illness was said to have occasioned the visit.

By advice of this medium, Mrs. Kaber was said to have employed two foreigners to appear at her husband's bedside in the night as ghosts and, as she expressed it, to try and shake a little civility into him.

Aroused from his slumber, Mr. Kaber was alleged to have attacked the two men and to have been stabbed to death by them in the struggle.

According to the newspaper, Chief Christensen said Mrs. Kaber had declared that she refused to pay the two foreigners when they reappeared after the funeral, asserting they had not fulfilled the role of ghosts, as she had intended, and that she would not involve herself by paying for murder.

Mrs. Kaber then was said to have fled to New York to escape the foreigners without advising the Cleveland police for fear of involving

Constantinople, June 10.—A Netherland, an Orthodox Russian, who has been appointed Russian Bolshevik ambassador to Ankara, has arrived in that city. It is said in Ankara received here. During his trip through Asia Minor, he is said to have made a number of addresses in which he declared the Bolsheviks would assist the Turkish Nationalists in their fight against the Allies.

Greek forces have been massed along the Western Asia Minor front for offensive against the Nationalists. It is estimated that 50,000 Greek troops are available for this struggle, while the Turks have about 60,000 effective men in Bursa and Smyrna. It is understood the British will not take an active part in the offensive.

**ORDERED OUT OF MEXICO,
MUST FACE TRIAL ON
CHARGE OF MURDER**

Cleveland, O., June 10.—Dominic Benigno and Charles Coletti will be turned over by Mexican authorities to the department of justice agents at Laredo, Texas, today for extradition to Cleveland, where they are wanted for the first degree murder of Wilfred C. Sly and George E. Fennell during a robbery last December, according to information received from Cleveland officers at Laredo.

As no extradition treaty exists between the United States and Mexico, it is understood that President Obregon had ordered the men sent out of the country.

OVER MILLION DOLLARS IN PROPERTY CHANGED 'HANDS HERE DURING MAY

Surpasses May of 1920 by \$17,058—Total Consideration For First Five Months of 1921 Is \$3,094,039—Figures For Year Expected To Exceed 1920.

The total consideration involved in property transfers for the city of London during the month of May amounts to \$1,073,066, surpassing the total for May, 1920, by \$17,058. That some big year is evidenced by the fact that although there were 358 transfers in May last year, compared to 333 during a similar period in 1921, the latter involves a bigger total consideration.

However, although the total consideration for May of this year is a record for the month, the total consideration on property transfers for the first five months of 1921 surpasses that of a similar period this year by \$165,361. Property transfers for these months in 1920 totalled 1,293, compared to 975 for 1921. The number of transfers for 1920 were distributed over the months as follows:

London, June 10.—Rear-Admiral William S. Sims, United States navy, was a guest at tea at the House of Commons this afternoon.

**CRERAR CLAIMS THAT
INQUIRY IS MERELY
A POLITICAL MOVE**

President of the United Grain Growers Makes Startling Statement.

NOTHING TO CONCEAL
Head of Farmers' Party Declares Commission Not Impartial.

Winnipeg, June 10.—The special session of the royal grain inquiry commission, held at Fort William last Saturday, was not a judicial inquiry, but a political manoeuvre, according to the president of the United Grain Growers, Hon. T. A. Crerar, president of the company, declared in a statement to the Canadian Press, Limited, last night. Mr. Crerar stated his company is determined to resist such unscrupulous attacks, and will protect his interests in the courts to the full extent of his legal rights.

Continuing, Mr. Crerar said the United Grain Growers, Limited, have nothing to conceal from any impartial tribunal. "The present commission, however," he said, "has confirmed our suspicions at the time of its appointment, that it is not impartial, but was appointed for political purposes. In other words, to discredit me and to injure as far as possible the grain growers' movement."

He said the commission, which has broadcast throughout Canada the falsehoods stated by a discharged employee, and without notice, contrary to all law and to even the decencies of civilized life, Mr. Crerar declared.

**ANTI-BOLSHEVIK
UPRISINGS ARE
SLOWLY SPREADING**

Tokio, June 10.—Determined anti-Bolshevik uprisings in the region of the Ural Mountains and at Petrovsk, about 200 miles south from Tobolsk, are reported in semi-official advice received here.

Petrovsk has been occupied by anti-Bolshevik forces and the movement from Moscow of reinforcements for soviet troops in Siberia is difficult as the anti-soviet elements control various points along the Trans-Siberian railway. Reports from Seoul state that Korean communists are holding meetings for the purpose of deciding on the program to be followed by eastern communists. After the conference, it is said, representatives will be sent to the international communist congress to be held in Moscow.

CANADA NOT REPRESENTED.
Ottawa, June 10.—Canadian Press.—Canada is not to be represented at the international conference of the welfare of women and children, which is to be held under the League of Nations in Geneva during the last week of June. The decision has been made by the Government on the general grounds of economy.

FIREMEN OFFER BLOOD TO SAVE WOMAN'S LIFE

Cleveland, O., June 10.—An appeal for volunteers for a blood transfusion was answered by 372 out of 500 members of the Cleveland fire department on duty yesterday. The crowd went out to save the life of Mrs. David Wilson, who was left in a serious condition from a caesarian operation performed a week ago, when twins—a boy and a girl—were born.

The boy died last Monday, but the girl probably will survive. The blood of the firemen's blood was found suitable. Coins were matched to see who would be accepted, and Charles L. Trinker won.

WILL TAKE TIME TO EFFECT UNION OF THE CHURCHES

Rev. D. C. MacGregor Is Appointed As One of Committee.

QUESTIONS TO SETTLE
Legislation May Be Necessary To Decide Property Ownerships.

Rev. D. C. MacGregor of this city has been appointed as one of the Presbyterian committee to confer with the other churches relative to church union. The announcement was made at Thursday's meeting of the General Presbyterian Assembly in Toronto.

"Although the decision was made," said Mr. MacGregor today, "to proceed with the proposed union with the Methodist and Congregational Churches of Canada, time will indicate the final consummation. There are a great many matters that must be straightened out, and I presume that the first move will be closer co-operation between the various negotiating churches in the missionary work in foreign fields, and no doubt the linking up of the various colleges and other educational bodies throughout Canada."

"Another important matter to be dealt with will be to secure legislation from both the Dominion and the Provincial Governments. The properties held by the different denominations will involve considerable straightening out, and the time-consuming process of period must elapse before ultimate consummation results. In the meanwhile, it will be found that the churches will gradually draw together by increased co-operation until the final objective is reached."

**BRAMMER AND MASON
CHARGED WITH THEFT**

Ex-Constable and Companion Alleged To Have Stolen Whiskey.

BIDDULPH FARMERS
McCaffery Tells of Search Being Made of House.

Roy Brammer, ex-constable of the local police force, and Fred Mason, both residents of the city, are on trial at the house of the court today, charged with the theft of whiskey last month from three brothers who live on a farm on the 9th concession of Biddulph Township.

William McCaffery, one of the brothers, in court today, told of Brammer and Mason coming to his place with a third man named Hindmarsh, who had purchased whiskey there on the same night that the theft was said to have been committed. Hindmarsh was handcuffed, and said that he did not know McCaffery, and that McCaffery did not know him.

Brammer threatened to lift witness off of lead if he made a move. He then told of a search of the house and the stealing of the whiskey.

When shown a badge, he said, and both men pretended to be officers acting under instructions from Licenses Inspector J. E. Keenleyside. Witness and a brother Joseph saw the number of the car which the thieves used, and later in London identified Brammer and Mason as the men who stole the whiskey. The theft is alleged to have been committed in May.

Hubert McCaffery also told of the raid on the house, and of identifying Brammer and Mason in London.

J. M. McEvoy, counsel for Brammer, wanted to know how dark the night witness said that it was moonlight, when the theft was committed.

McCaffery and his brother both stated that the prisoners came to the house before 10:30 and 10:40 o'clock. Mr. McEvoy says that he will prove that the moon did not rise until after 11 o'clock that night.

When court resumed after the adjournment for lunch Hubert McCaffery was still on the stand. Albert M. Judd is acting for Mason and J. B. McKillop is prosecuting.

**WOULD HAVE JAPAN
TAKE INITIATIVE IN
DISARMAMENT MOVE**

Osaka, Japan, June 10.—Resolutions providing that a petition be sent to the Japanese Government asking it to take the initiative in communicating with Great Britain and the United States for the purpose of calling a conference relative to disarmament have been passed unanimously by the disarmament committee of the chamber of commerce here. The committee also decided to conduct an investigation with a view to gathering more information regarding armament restrictions.

REAR ADMIRAL SIMS DECLARES PROTESTS MADE BY U. S. IRISH BECAUSE HE WAS TELLING TRUTH

Repeats At Function in His Honor Today That He Will Not Repudiate One Word of Address Made Last Tuesday — Wires Denby That What He Said Was Nothing in Addition to Statements Previously Made in U. S.

London, June 10.—The reply of Rear Admiral Sims to the request and Secretary of the Navy Denby for an explanation of his speech here Tuesday, expresses the opinion of Admiral Sims that some parts of the speech, to which objection had been taken, had been garbled. This was learned unofficially, but on good authority here today.

In his answer, which is not long, Admiral Sims declares he said nothing in his address which he had not said before in speeches in the United States and in his book.

London, June 10.—Rear-Admiral Sims made no direct mention of United States residents in sympathy with the Irish Republican cause today during a 40-minute address at a luncheon given in his honor by the United States Luncheon Club.

In an apparent allusion, however, to his remarks of last Tuesday, when he addressed the English-Speaking Union, the admiral said: "Perhaps we have used too energetic adjectives on some occasions, but let us hope that will be amicably explained away." The admiral paused a moment and then added: "But I am going on doing the same thing."

This declaration brought from the 200 guests a repetition of the uproarious applause which had greeted the remarks of Wilson Cross, vice-president of the United States Chamber of Commerce in London, in introducing Admiral Sims.

"He is stung again, but he says he will stand by what he has said," Sir Cross told the assembled company. "I am sure that the man who stands with him—and so will all full-blooded, true, honest-thinking United States citizens."

Always Told Truth.
Mr. Cross alluded to the marked cordiality with which Admiral Sims had been entertained by men among the most notable in the country since his arrival in England and he presented the admiral in the characterization usually applied to Washington—"First in war, first in peace, first in the hearts of his countrymen."

Admiral Sims, in reply, said he had attempted on all occasions to say what he wanted to say, and he believed he had always told the truth as he understood it. He was afraid he had gone to excess in telling the truth, and he feared he had done so the other day.

"At least, in the opinion of certain people," he added, "he had been acclaimed by critics as 'the most popular British admiral in the United States navy,' and had been accused of being pro-British."

"If," continued the admiral, "I was accused of being pro-French after I had been naval attaché in Paris for four years. I am pro-British, pro-French, and pro-Allied."
