responsible for the drafting of the Covenant; the Government considered it desirable that this explanatory statement should accompany the Covenant. If my hon, friend has not seen the statement I am quite prepared to let the motion stand over until to-

Mr. McKENZIE: I shall be glad to see the statement.

Sir SAM HUGHES: I did not catch the minister's explanation of the explanatory note which he laid on the Table a moment ago. Was it an essay issued by somebody, or what was it?

Mr. ROWELL: The document I laid on the Table was the Covenant of the League of Nations, accompanied by an explanatory statement prepared by the British Empire Parliamentary Delegation at the Peace Conference, and laid on the Table of the British House of Commons and printed as a Parliamentary Paper there. I am sure that this explanatory statement would aid in the understanding and interpretation of the Covenant by those who wish to get at its real meaning, particularly the laymen who are not so accustomed to studying a legal document as the lawyers are.

LABOUR CLAUSES OF PEACE TREATY, WITH EXPLANATORY STATEMENT.

Mr. ROWELL: I desire to lay on the table of the House the Labour clauses of the Peace Treaty, with an explanatory statement prepared at the Peace Conference and published in Great Britain. It appears to the Government to be desirable that this explanatory statement with reference to the Labour clauses should also accompany the document as a printed Parliamentary Paper. If my hon, friend has not seen the explanatory statement I shall be glad to leave the motion for printing over until to-morrow.

Mr. CANNON: I am very much surprised that these documents are produced after the debate is over. Why were they not produced before the debate started?
