of insurance vary from time to time and lowest tenders are accepted.

BOARD OF COMMERCE REPORT.

*Mr. CASGRAIN:

When does the Government expect that the Board of Commerce will make its report to the Government?

Sir GEORGE FOSTER: I am not certain just when the report will be brought down, but my latest information is that it is nearly ready for laying upon the table of the House.

TAXATION OF "MUTUAL" INSURANCE COMPANIES.

*Mr. RINFRET:

1. Does the Government intend to impose a tax of 15 per cent on the "mutual" or non-authorized insurance companies?

2. If so, how many companies, approximately,

are to be affected by said tax?

CANADIAN NORTHERN PORT ARTHUR TERMINALS.

Mr. BUREAU:

1. Have the terminals, lands and buildings forming part of and operated by the Canadian Northern Railway system at Port Arthur been turned over to the Government as part of the

system of the Canadian National Railways?
2. Have the ore docks and buildings located at Port Arthur and forming part of and oper-ated by the Canadian Northern Railway been turned over to the Government as part of the system of the Canadian National Railways?

3. Have the lands, buildings and other properties of the Atikokan Iron Company acquired by the Government and are they now controlled and do they form part of the Can-

adian National Railway system?

4. Have the lands controlled by the Lake Superior Terminal Company, part of the Mac-kenzie-Mann Company or Canadian Northern Railway system, been acquired by the Government and are they now the property of and operated by the Canadian National Railways?

Hon. Mr. CALDER:

1. The terminals, lands, and buildings used by the Canadian Northern Railway system at Port Arthur are owned by said company.

2. No, but the Canadian Northern Railway is operating these premises under

lease.

4. The Canadian Northern Railway owns the entire capital stock of the Lake Superior Terminals, Limited, thereby controlling any lands or properties owned by that company.

EXCESS BUSINESS PROFITS TAXATION.

*Mr. CASGRAIN:

How much has the Government received as an additional revenue through the Excess Business Profits Tax Act over and above what they would have received under the Income Tax Act, assuming that all companies would have been taxed at 10 per cent?

Sir HENRY DRAYTON: To answer this question would necessitate the examination of approximately 100,000 returns and the employment of many accountants.
