ALLEGED INFILTRATION OF FLQ BY UNITED STATES CENTRAL INTELLIGENCE AGENCY—REQUEST FOR REPORT

Mr. Eldon M. Woolliams (Calgary North): In light of the Solicitor General's answer which was not clear and in view of the sensitivity of relations with the United States at this time, as has been discussed earlier, would the Prime Minister as the head of the government make a statement with reference to this alleged infiltration indicating whether there was knowledge on the part of the government and whether government acquiesced in the action of the CIA and is still acquiescing and handing over the security of our nation to another country?

Right Hon. P. E. Trudeau (Prime Minister): Like the Solicitor General, I made some preliminary inquiries and like him I repeat that it would be important to make further inquiries. The preliminary inquiries, in which I have confidence, are to the effect that there are no CIA agents in Canada. Certainly if there are some they are not here with Canada's knowledge and acquiescence.

TRAINING ALLOWANCES—REMOVAL OF REQUIREMENT OF THREE YEARS IN WORK FORCE IN ORDER TO QUALIFY

Mr. S. Perry Ryan (Spadina): My question is for the Prime Minister. As recommended by the Economic Council of Canada's latest report, is the government going to lower the three-year eligibility requirement for training allowances?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, this report was only made public yesterday and I have not had time to read it yet.

**Mr. Ryan:** Is the government now going to table the government's studies of alternative eligibility requirements that are referred to in the Economic Council of Canada's report?
