SDB Insurance Rates—There will be no increase before the end of 1972 with respect to SDB insurance rates which have been in effect since the plan was restructured in 1966

Mess Dues—The amount paid by each member for mess dues is set by a vote of the members of each mess at a general mess meeting, subject to the approval of the commanding officers. It will differ between messes according to their particular needs.

Clothing Allowances or Costs—Clothing prices are normally reviewed annually and adjustments are made as required to reflect the latest procurement costs. A study is presently under way to determine whether there should be any adjustments to the prices charged for clothing and to determine whether the rate of Clothing Upkeep Allowance should be changed. As the results of this study will not be available until the spring of 1972, it is not possible to forecast what the net result of any changes in clothing prices or allowances will be.
