Mr. F. Oberle (Prince George-Peace River): Mr. Speaker, I am glad to be able to contribute to this suggestion. The point of privilege certainly must be that the minister misled the House today.

An hon. Member: Right.

Mr. Oberle: He said that he has evidence with regard to the private sector and the province of British Columbia. Let us not belittle this question; it is a crucial question because 60 per cent of the economy of British Columbia depends on the forest industry. The minister said he has evidence that the private sector is prepared to assume the responsibility and the financing of the B.C. forest products lab. I suggest, Mr. Speaker, that the minister has evidence that the private sector is not prepared to assume responsibility. I have the evidence.

Mr. Fraser: So do I.

Mr. Oberle: And so does the minister. He has clear evidence, in writing, that the private sector is not prepared, for obvious reasons, to assume this responsibility. I say the minister has misled the House by implying that he has—

Mr. Speaker: Order, please. I think we can see the difficulty that we get into when we embark on procedural grounds that are not well founded. As we enter into these discussions, the more permissive the Chair becomes in allowing discussion of points that are not well founded in procedure, the more likely we are to get into further and new questions of procedure. We are certainly very close to raising new questions when these kinds of accusations are made.

Essentially, the minister has stated his position. Members on the opposition side have stated that they disagree with the interpretation given by the minister today. That remains a disagreement and there is not, procedurally, either a point of order or a question of privilege.

Mr. Fraser: Mr. Speaker, I rise on a point of order.

Mr. Speaker: Order, please.
