No. While the admission of an independent immigrant to Quebec requires approval from that province, the admission of a spouse, i.e. member of the family class, does not. This approach is consistent with the federal government's commitment to family reunification which is one of the objectives of the Immigration Act.

## NATIONAL ANTHEM ACT

DESIGNATION OF WORDS AND MUSIC OF "O CANADA"

On the order:

Second reading and reference to the Standing Committee on Communications and Culture of Bill C-26, an act respecting the national anthem of Canada—the Secretary of State.

**Mr. Pinard:** Madam Speaker, in accordance with the order of the House, the motion previously passed will have to be amended so that the bill can be referred to Committee of the Whole.

Hon. Francis Fox (Secretary of State and Minister of Communications) moved that Bill C-36, respecting the national anthem of Canada, be read the second time and referred to Committee of the Whole.

He said: Madam Speaker, it is a real honour for me today in this House to propose the second reading of the bill respecting the national anthem of Canada. I acknowledge that it is only through the unanimous consent of all parties that it is possible for us to proceed today to the consideration and, I hope, passage of the bill.

Madam Speaker, "O Canada" is considered by all Canadians as the national anthem of their country but it has never been proclaimed as such by Parliament. I therefore ask the House today to catch up with history and to grant legal status to a heartfelt tradition.

Before outlining the circumstances surrounding the writing of this anthem, I would like to go further back in history, to the origins of the word "Canada". Among the possible explanations of this name, one is that in the sixteenth century, the
