## TESTING OF CRUISE MISSILE

overwhelming superiority in nuclear arsenals during the fifties, sixties and early seventies, the Soviet Union felt compelled to do just the opposite and will now certainly match deployment of Cruise missiles with deployment of their own, I move, seconded by the Hon.
