#### RELEASE OF VACLAV PIVRNEC DETAINED IN CZECHOSLOVAKIA

The petitioners ask the House of Commons to urge the Government of Czechoslovakia to issue Vaclav Pivrnec a permit to rejoin his family in Canada.

### SINGING OF CANADIAN NATIONAL ANTHEM AT INTERNATIONAL EVENTS
