# IMPACT OF DEINDEXATION OF PENSIONS

Mr. John R. Rodriguez (Nickel Belt): Mr. Speaker, my question is directed to the Minister of National Health and Welfare. The Minister is aware of recent statistics showing that the increase in the number of elderly people will be greater and faster in Quebec than in Canada as a whole. The people of Quebec will therefore be more severely affected by the impact of the deindexation of old age pensions. My question is this: Why did the Minister choose to withhold \$245 million from retired people by deindexing old age security pensions when he had a fourth option—he could have collected \$600 million by maintaining the capital gains tax?
