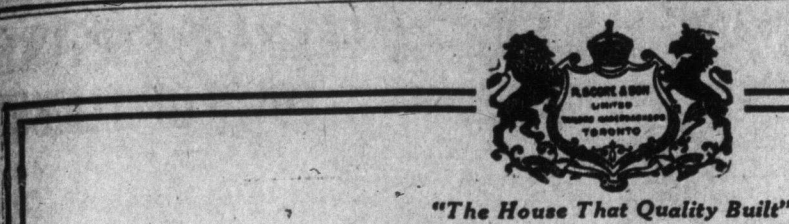

## INCREASE REVENUE FOR LARGE CITIES

Bill Introduced in Legislature  
Will Have This  
Result:

**STOP LOSS BY FLOODS**

Government Urged to Take  
Action Regarding  
Grand River.

Means of increasing the revenue of the City of Toronto have been discussed for some time and the city officials have been busy trying to find a way whereby more money would flow to the city treasury. Yesterday Hon. J. B. Lucas introduced a bill in the legislature which, if made law, will have the effect of materially increasing the city's revenue. It provides that fees for the registration of deeds and other such papers will be raised by approximately 30 per cent, and in Toronto, where the proportion of such fees paid to the city is about 90 per cent, the amount in a year would be considerable.

The bill is an amendment to the Registration Act and provides that the entire province. The proportion which a registrar retains and that which is paid to the municipality works on a sliding scale, so that the larger the centre the larger becomes its revenue from this source.

Grand River Discussion.  
Another matter of importance in yesterday's brief session was a motion for a return bearing upon information in regard to the Grand River. With a view to giving relief to the people who live adjacent to the river, J. H. Haun, South Brant, urged the government to take some action whereby floods would be avoided. He said people were living in constant dread of the spring and that already hundreds of thousands of dollars' damage had been done in recent floods. He pointed out further that by conserving the water supply along engineering lines which would raise the level of the electricity could be developed would be secured at a time when such power was greatly needed.

Hon. Friday Macdonald, Minister of public works, did not object to the return being brought down, but told of the plans now under way and said the Ontario Hydro-Electric Commission was investigating. Because of the heavy expenditure involved he did not think it wise to act without full consideration. The question of diverting water by way of Dundas was being discussed. To carry out the plans suggested it would be necessary to either do this or build catch basins which would raise the level of the water in the spring season and make it available the year around. The motion was carried and the information will be forthcoming.

Bread Bill Withdrawn.  
Charles McCrea, Sudbury, moved the second reading of his bill to amend the Bread Sales Act saying it would allow contracting bakers to make a more convenient loaf for restaurant, dining car service and such. Hon. Mr. Lucas thought it would give makers of under-weight bread a loophole by which they could evade the law, but said special consideration might be given in special cases. On this basis the bill was withdrawn.

A bill to amend the Administration of Justice Act was introduced by Hon. Mr. Lucas, which provides for a new schedule of rates for the legal profession. The Dominion standard of fees would be adopted, he said.

The second reading was given a bill which affects the City of Toronto, giving it the right to elect 10 aldermen, the highest five remaining in office for two years, the remainder for one year, thereafter electing five aldermen each year. It is somewhat similar in principle to the bill which passed the municipal committee recently respecting the civic government of Quebec.

The board of control yesterday granted \$10,000 to the Great War Veterans' Association after listening to Sergeant William E. Turley, Sergeant W. O'Connor, Lieut.-Col. E. B. Hardy, D. S. O., and other wounded veterans.

Controller McBride wanted the city to be represented on the executive of the G. W. V. A., but it was explained that this was unconstitutional. Controller O'Neill opposed the grant, as the finance commissioner had reported that the same work being performed by the veterans was being done by Sergeant-Major Craigston's office in the city hall.

An amendment by Controller McBride to make the grant \$6,000, the same as last year was voted down. Mayor Church and Controller Robbins and Maguire favored the \$10,000 grant asked for by the veterans.

The board endorsed a resolution passed by the Brantford city council asking that the property qualifications for aldermen be abolished. The mayor and Controller O'Neill were opposed.

Mayor Church objected to endorsing another resolution asking that the control of the finances of the board of police commissioners be given to the city council. No action was taken.

The mayor was indignant. "If Willy was most shabbily treated," he said, "if he is not reinstated I will get him a job myself outside."

**TELLS OF CAMPAIGN  
IN MESOPOTAMIA**  
Speaker at Empire Club Was Thru  
Advance of Sir Percy Lake's  
Column.

B. H. McClain, formerly secretary of the Calcutta Y. M. C. A., for three years and two years in London, afterwards with Sir Percy Lake's forces which were sent to relieve General Townshend at Kut-el-Amara, addressed the Empire Club yesterday and gave a vivid account of the sufferings of the troops on the ill-fated expedition which had to surrender to the Turks.

He paid a glowing tribute to the fidelity and courage of the Indian troops and the British and Canadian forces in France, at Salonica, in Egypt, along the Suez Canal, in Palestine, in German East Africa, and in Mesopotamia. The speaker reported his service, he said, was inadequately appreciated, and their destiny was inseparably linked with ours.

He recounted the efforts of the German Empire to gain control of the Turkish territories and the Bagdad Railway. Britain's policy was to secure the value of Mesopotamia as the only remaining great region capable of colonization, but Germany had. The port of Basra, which was the Turkish port there and all the races of the world mingled there today.

In a central position neglect of the Persian Gulf would imperil British interests in the east. German ambitions were for an empire from the North Sea to the Persian Gulf. Should they be realized it would permanently end Britain's control of India, Australia, Hongkong and other eastern possessions.

An economic point was emphasized when it was stated that the government would ultimately save money for by the better care of outdoor patients there would be less indoor patients, and the cost of indoor care would be reduced.

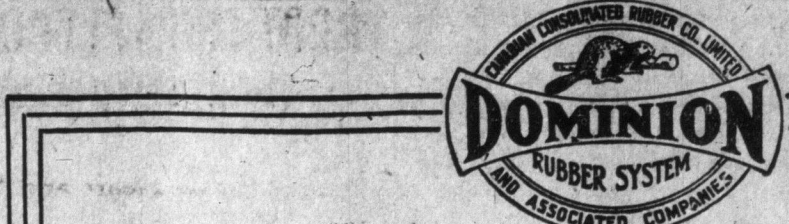

United States Church Will  
Raise Hundred Million  
in Five Years.

**FOR MISSIONARY WORK**

Movement in Canada to Raise  
a Proportional Amount  
is Launched.

Toronto Anglicans are taking the lead in starting a new great forward movement for missions on a large scale. Rev. Dr. W. E. Taylor, the new secretary of the Anglican Laymen's movement for missions, outlined the proposed plans at St. James' parish house at a luncheon yesterday. It was explained that the Methodist Episcopal Church in the United States had started a campaign to raise one hundred million dollars for missions during the next five years. A proportionate effort was a proposed objective by the churches in Canada. The amount to be made an objective by the Anglicans in Canada, and the plans for the new laymen's movement for missions would be decided at the meeting of the general synod at Winnipeg in September, and would, Dr. Taylor considered, be requested with equal interest to the other great question to come before the general synod, namely, action upon the revision of the prayer book.

Dr. Taylor announced that he was leaving immediately for an organizing tour by laymen's missionary committees in Quebec and the east. This work, and an explanation at the places visited, or the importance to be attached to the action to be taken at the general synod regarding the projected forward movement, would be the principal work to be undertaken until the meeting of that body. The fact was brought out that the missionary Anglican contributions last year were not affected by the calls for patriotic funds. This was taken as an indication that the continuance of the year would not preclude the general synod approving of a great missionary campaign.
