**TRADE REGULATIONS WITH GREAT BRITAIN:—**Motion by Mr. McNeill, That if and when the Imperial Parliament admits Canadian products to British markets upon more favourable terms than foreign products, Canada will accord corresponding advantages, &c., 251. Amendment moved by Mr. Davies, Inasmuch as Great Britain admits Canadian products free of duty, the scale of duties imposed on British goods should be reduced; Negatived, 252. Motion agreed to, 253.
