5. Has the government any record or report

of such accident or accidents?

6. If so, what is the nature of such report. and by whom was it sent in?

Hon. Sir FREDERICK BORDEN (Minister of Militia). The same answer to this question.

Mr. WORTHINGTON. I do not think that the returns asked for would cover these

Sir FREDERICK BORDEN. I assure my hon. friend that the return will include every thing down to the date at which it is laid on the table.

Mr. FOSTER. The questions will then stand I suppose, Mr. Speaker ?

Mr. SPEAKER. I understand the reply to be that the return ordered by the House will bring down all the information asked

Mr. BERGERON. There can be no harm in letting the question stand.

ANNUAL DRILL-LEAVE OF ABSENCE.

Mr. WORTHINGTON asked:

1. Referring to militia orders, February 9, 1907, number 34, under section 1, a clause respecting the annual leave of civil servants, is it the intention of the government to restrict the privilege re annual drill and camps to civil servants in the inside departments only, or to extend the same privileges to the outside service as well?

2. Is the government aware that members of the outside service attending annual drill and camp have the time expended in so doing de-

ducted from their annual leave?

Hon. Sir FREDERICK BORDEN (Minister of Militia). The question of leave of absence for civil servants who are members of the militia in excess of their annual leave, to enable them to perform annual training in camp, was brought to the attention of the Department of Militia and Defence by other departments of the Public service at Ottawa, and the approval of His Excellency the Governor General for such leave was obtained and notified in militia order No. 34 of February 9 last.

Sir FREDERICK BORDEN.

The order provides such leave for the inside service only, but there is no reason why it should not be extended to the outside service if, after a trial, it has been found to be in the public interest.
