Because of the manner in which the question has been put I do not think it deserves any other reply than that since this matter is now before the courts it would be most improper for any minister of the crown to make a statement or reply such as that which the Leader of the Opposition now seeks.

Mr. Diefenbaker: Mr. Speaker, I now ask the hon. gentleman this question, which does not concern the stand to be taken by the government. Does the government intend to put in defences to the actions that have been taken and have the matter come before the courts, or does it intend to settle these actions started by the law firm of which Mr. MacTavish, Q.C., is a member?
