SECURITY OF UNITED STATES TRANSPORTATION ROUTES—ANTI-SUBMARINE PATROLLING

Mr. David Anderson (Esquimalt-Saanich): Mr. Speaker. I have a supplementary question for the Acting Prime Minister in his capacity as Secretary of State for External Affairs regarding the security of United States oil routes. In view of the fact that the United States Department of the Interior published earlier this month a study showing that the Alaska pipeline and the offshore tanker route would be entirely within United States hands and thus would be more secure than a pipeline passing through Canadian territory, would the minister please inform me whether or not the United States government has entered into discussions with the Canadian government with a view to handing over anti-submarine patrolling on the west coast of Canada to United States forces rather than, as is presently the case, leaving it to Canadian naval units?

FEASIBILITY OF CONSTRUCTING PIPELINE FROM WESTERN CANADA TO MONTREAL—APPEARANCE OF MINISTER AND NATIONAL ENERGY BOARD CHAIRMAN BEFORE COMMITTEE

Hon. George Hees (Prince Edward-Hastings): Mr. Speaker, I have a supplementary question for the Minister of Energy, Mines and Resources. The minister stated that he has no study to present to the House for us to examine. Since this is a most important matter for the Canadian people, would the minister and the chairman of the National Energy Board be willing to appear in the near future before the appropriate committee of the House to answer questions so that the Canadian people can become better acquainted with the facts surrounding this important matter?

Hon. J. J. Greene (Minister of Energy, Mines and Resources): Mr. Speaker, when the estimates of the National Energy Board are before the committee we would certainly be most pleased to appear. I reiterate that the question of the economic viability of pipelines in Canada is left to the private sector. It is not for the government to determine whether or not to build pipelines; that is not the way we operate.
