DISPUTE BETWEEN ALCAN AND ST. LAWRENCE WORKERS PROTECTIVE UNION—DEPARTMENTAL INVOLVEMENT—FUND FOR DISABLED MINERS

Mr. John Lundrigan (Gander-Twillingate): I have a question for my friend, the Minister of Labour. Has the minister's department been involved in an effort to resolve the labour dispute between Alcan and the St. Lawrence Workers Protective Union, which has gone on since April 19, 1971, or is the department planning to become involved?

Hon. Bryce Mackasey (Minister of Labour): We do not plan to get involved and we are not involved in it because the dispute falls under provincial jurisdiction.

Mr. Lundrigan: Perhaps the minister, in co-operation with the Minister of National Health and Welfare, can answer this question. Has the minister's department been requested to contribute to the fund for disabled miners or the families of deceased miners at St. Lawrence which was recommended by the Royal Commission on Radiation which was set up over two years ago?

Mr. Mackasey: I will have investigations made in my department to see whether such a request has been received. At the same time, I will take the liberty of checking with the Department of National Health and Welfare and will report back to the hon. member on an appropriate occasion in the House.
