Jean Marchand (Minister of Transport): The Management of Canadian National Railways advises: CNR incurred a deficit of \$2.1 million in 1970, \$2.2 million in 1971 and estimates a deficit of 2.4 million for 1972. These deficits apply to both the Mount Royal Tunnel and South Shore Commuter Services. No subsidy has ever been received for losses incurred on commuter operation. CNR has been obliged to cover these losses from general revenues.
