STE SCHOLASTIQUE—POSSIBLE RE-OPENING OF EXPROPRIATION CASES

In view of the displeasure expressed by many of the Sainte-Scholastique expropriated people whose spokesmen are here today in the house, does the Minister intend to re-open the Ste Scholastique file to review the apparently justified claims of the people expropriated, especially in the field of farm rentals, so that they will be treated more fairly?

Hon. Jean Marchand (Minister of Transport): Mr. Speaker, Mirabel involved 3,142 cases of expropriation, 2,587 of which were settled, 135 are being settled and 80 have not been settled. Furthermore, 340 have received advances.

SUBSIDY ON FLUID MILK—AGREEMENT OF PROVINCIAL MARKETING BOARDS

I should like to ask the minister whether he, on behalf of the government, has placed before the provincial milk marketing boards formal proposals embodying the announcement made in the Prime Minister's statement of yesterday and how soon he expects agreement will be reached?

Hon. E. F. Whelan (Minister of Agriculture): A meeting is now going on in the Sir John Carling Building between the Canadian Dairy Commission, the industry and producer representatives. We hope some conclusion will be forthcoming from this meeting this afternoon.

SUBSIDY ON FLUID MILK—REQUEST FOR ASSURANCE CONSUMERS WILL RECEIVE BENEFIT

Mr. Terry Grier (Toronto-Lakeshore): Mr. Speaker, I have a question for the Prime Minister in the same general area arising from the assurance which he has seen fit to give in respect of a subsidy on milk for consumers. Is the Prime Minister prepared to guarantee to the House that this milk subsidy will be passed on to the milk consumers?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, that is the intention in the statement I made yesterday. The federal government is prepared to pay a five-cent subsidy per quart on milk, provided the provinces give the assurance that was mentioned in my statement that they will either contain or roll back the prices.

NORTHERN AFFAIRS

ACTION TO ENSURE BENEFIT OF SUBSIDIES RECEIVED BY RESIDENTS OF NORTHERN AREAS

Mr. Erik Nielsen (Yukon): Mr. Speaker, since there are no marketing boards similar to those which exist in the provinces in the two northern territories, the Yukon Territory and the Northwest Territories, and since this is a matter falling under the jurisdiction of the Minister of Indian Affairs and Northern Development, what steps is he taking to ensure that the citizens of Canada in those two northern areas receive the same kind of benefits in respect of these announcements concerning subsidies.
