TIME OF SETTING UP OF JOINT SENATE-COMMONS COMMITTEE TO INQUIRE INTO FOOD PRICES

Mrs. Grace MacInnis (Vancouver-Kingsway): Mr. Speaker, my question is for the Minister of Consumer and Corporate Affairs. In view of the pre-new year jump in beef prices to the consumer, rising as high as 11 per cent in British Columbia, what is the earliest date at which the government can set up its announced Senate-Commons committee to inquire into food prices?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): Mr. Speaker, I am sure that this is a matter on which the House leaders will want to consult and I am sure they will look upon it as a matter of urgency with regard to the legislative program.

Mrs. MacInnis (Vancouver-Kingsway): A supplementary, Mr. Speaker. In view of the government's oft-repeated claim that it wants more communication with the Canadian public, what is the reason for keeping secret the possible date of the setting up of this committee?

Mr. Gray: Mr. Speaker, this is a decision for the House, not for the government, and I hope that the House will make such a decision at an early date.
