## ANTI-INFLATION BOARD

REASON BOARD FAILED TO PREVENT INCREASES IN HOUSING COSTS

Mr. John Gilbert (Broadview): Mr. Speaker, my question is directed to the Minister of Finance. Since the consumer price index which was released this morning shows that the housing component has increased 11.1 per cent in the past year compared to a 10.4 per cent increase when the government's controls program was brought in, can the minister indicate to this House the reason for the increase? Will he make a statement to the House on motions next week presenting information from his department why the Anti-Inflation Board has not prevented the further escalation in housing costs?

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, if I could draw the hon. member's attention to the release of Statistics Canada this morning, he will note that the principal reason for the increase in the housing component of the consumer price index was the increase in municipal taxes in Canada which comes into the October figure. As I have had occasion to mention to the House before, the government of course is not in a position to control the taxation policies either of the provincial or municipal governments, and for this reason the anti-inflation program has not been in a good position to restrain those increases which it is true the consumer must pay.

## REASON FOR REVISED GUIDELINES ON PRESS AND PROFITS OF LAND DEVELOPERS

Mr. John Gilbert (Broadview): Mr. Speaker, I am sure the minister realizes it is not only municipal taxes but is also the land profits that have been made. Since the major Canadian land developers are reporting huge profit increases such as Cadillac Fairview up 64 per cent, Markborough Properties up 30 per cent and Genstar up 21 per cent, can the minister indicate to this House why the government approved last Friday the revised Anti-Inflation Board regulations which widened even more significantly its guidelines on prices and profits of land developers?

Hon. Donald S. Macdonald (Minister of Finance): Mr. Speaker, one of the principal reasons was that the land realization price of course would not be an increase in price which has occurred only during the control period. It may well indeed reflect the ownership of the land extending well before the period of controls became effective. We have indicated for the [Mr. Lawrence.]

period of the controls that any increase that occurs during the period of the controls, on the contrary, would not be entitled to be taken out of income or be exempt from excess revenue.

PURPOSE OF MEETING OF OFFICIALS IN MONCTON—POSSIBILITY OF PARTICIPATION BY BUSINESS AND LABOUR

Mr. Leonard C. Jones (Moncton): Mr. Speaker, my question is addressed to the Minister of Regional Economic Expansion. Can he confirm that meetings have been held in Moncton in the last few days between his officials from Ottawa and the local department of DREE? Would he advise what the purpose of these meetings is and if they have been behind closed doors whether consideration has been given to inviting participation from business and labour organizations in the region.

Hon.
