BUSINESS OF THE HOUSE

Mr. Nielsen: Madam Speaker, I rise on a point of order with respect to House business. Since there seems to be some misunderstanding, I wonder if the government House leader might confirm that, after dealing with the motion now before us, we will be proceeding with Bill C-15, the livestock feed assistance bill, and then with Bill C-20, the bill on the FBDB. Is that correct?

Mr. Pinard: Madam Speaker, that would be correct if we terminate debate on the order in council before ten o'clock tonight. If we finish debate on the order in council today, tomorrow we will consider Bill C-3, an act to amend the Unemployment Insurance Act of 1971. If we finish consideration of the order in council before ten o'clock tonight, rather than going to Bill C-3 for the remainder of the time, we will consider third reading stages of Bill C-20, and Bill C-15.

Mr. Nielsen: In the reverse order or in the order expressed by the government House leader? Which is first?

Mr. Pinard: If we are to get the two bills, it does not matter, but if we are not to get the two bills, we would prefer to consider Bill C-20 first.

Madam Speaker: The hon. member for Vancouver-Kingsway (Mr. Waddell).

Mr. Waddell: Madam Speaker, I think my question of privilege can wait until tomorrow. I will try to raise it then.

VIETNAMESE REFUGEES

Question No. 60—**Mr. Cossitt:**

What was the total amount of public money spent to date in bringing into and settling in Canada Vietnamese refugees and what is the estimated cost figure for the entire project?

Mr. Dennis Dawson (Parliamentary Secretary to Minister of Employment and Immigration): The preliminary figures to date on the bringing in and settling of Vietnamese refugees in Canada are as follows:

1979-80	\$57,775,000.
1980-81	\$63,666,000.

It is estimated that the total cost for the entire project will be some \$122,000,000. This includes staging areas, resettlement, language training, transportation and other costs.
