#### POSTAL RATE INCREASE

#### Question No. 3,189—Mr. Cossitt:

- 1. Did the government announce a postal rate increase and, if so, did it take into consideration the disastrous effect that this might have on charitable organizations such as the Christmas Seal campaign, the Easter Seal campaign and the United Way, since these groups use the postal service quite heavily for solicitation, the receiving of donations and the sending of receipts?
- 2. Will the government take immediate steps to change any proposed increases to exempt such groups from postal charges that might greatly hinder their essential work on behalf of many persons?
- Mr. Gary F. McCauley (Parliamentary Secretary to Minister of Consumer and Corporate Affairs): 1. Yes. Representations were received from interested parties, including charitable organizations, and were given Canada Post's full consideration.
- 2. It is not Canada Post's intention to effect any changes at this time concerning postal rates.
