LOW-LEVEL FLIGHTS AT ARMED FORCES BASE AT GOOSE BAY

Mr. Dan Heap (Spadina): Mr. Speaker, I also have a petition from a number of Canadians living in Surrey, White Rock, Delta and Vancouver, British Columbia, as well as Toronto, concerning the low-level flight training conducted at the Goose Bay, Labrador, Canadian Forces Base on behalf of a number of NATO air forces. They are concerned that it disrupts the life of the native people there and damages the environment and is in fact not defensive but a provocative and aggressive war fighting action tending to endanger world peace. Therefore, they request that Parliament ask the Prime Minister (Mr. Mulroney) to ensure that he will end all low-level flight training at Goose Bay and cease negotiating with NATO for the establishment of a larger base there.
