JOB CREATION IN ATLANTIC CANADA—PRIME MINISTER'S STATEMENT

Mr. George Henderson (Egmont): Mr. Speaker, unemployment in Atlantic Canada is unacceptably high. In some areas the official unemployment rate is 30 per cent. The unofficial rate is much higher. Since September, 1984, the Conservative Government has slashed its budgets for regional development and job creation. Atlantic Canada has been hardest hit by these cuts.

However, what did the Prime Minister (Mr. Mulroney) recently say? On Tuesday of last week he claimed that his Government had created jobs in Atlantic Canada at twice the rate of the previous Government. Nothing could be further from the truth, Mr. Speaker. Then, on Thursday, the Prime Minister gave a regional breakdown of his Government's job-creation record. He seemed to have forgotten what he said only two days before. On Thursday he said, "Some 46 per cent of the jobs created were in Ontario, 28 per cent in Quebec, 22 per cent in western Canada, and so on". The "and so on" is Atlantic Canada.

The figures show that three regions got 96 per cent of the jobs created while the "and so on", the Prime Minister's new description of Atlantic Canada, got only 4 per cent of the jobs. The words "and so on" are an insult to our region. The unemployed in Atlantic Canada are fed up with the Prime Minister's exaggerated rhetoric. What they really need is concrete action by the Government to create jobs.
