DOUGLAS CASE IS POSTPONED

Boyd and Stevenson Again Bailed-Accused Plead not Guilty

Will be Tried at Next Assizes—Judge Considers That Former's Bail Was

At the sitting of the Assize Court yesterday, the grand jury entered the court room at 4 o'clock in the afternoon, and announced that they had found a true bill against Wm. Boyd and Hugh Stevenson for conspiracy to defraud ex-Ald. Hugh M. Douglas of the sum of \$10,000 and other large sums of money.

The accused were then arraigned before the judge, and each pleaded not guilty to the charge, Mr. J. P. Mabee, of Stratford, acting as Crown prosecutor.

Mr. Ed. Meredith, K. C., who appeared for Stevenson, applied for a postponement of the trial on the ground that the accused were only ground that the accused were only committeed for trial on Monday, and that it might be necessary to issue a commission to bring certain witness es for the defence from St. Louis. Mr. O. L. Lewis, of Chatham

made the same request on behalf of Boyd. Mr. Mabee was agreeable, and hi-man till the next lowed a postponement till the next

Mr. Meredith then brought before His Lordship the question of bail, and characterized that given before Police Magistrate Love as being exorbitant and beyond all reason. The accused's personal bail were bonds amounting to \$10,000 each and personal bail of \$12,000 each. He asked His Lordship to consent to a reduc-

sonal bail of \$12,000 each. He asked His Lordship to consent to a feduction in the amount.

Mr. Mabee opposed the application of counsel for the accused, and gave the Court an outline of the circumstances, stating that in the race at St. Louis, Boyd fell down on the track. It was afterwards found, the counsel said, that the cinder on which he stumbled was about the size of a copper.—Laughter.

The judge thought that the bail sought by the Crown was too high, and fixed the amount at \$5,000 each.

Mr. Lewis made application to have additional particulars which had been furnished by the Crown regarding the charges affixed to the indictment, so that the defence would know exactly what case they had to meet.

Mr. Mabee submitted that the evidence in the police court examination of Mr. Douglas, as taken by a stenographer, was quite sufficient for the purposes of the defence.

His Lordahip refused to make out the order for the attachment of the particulars in the meantime, but said he would hear the application again.

Acoused were then formally bailed to appear at the next court, their bondsmen being the same as before,—Lendon Free Press.
