American and British Papers Print Special Articles.

A Proposal Is Made to Internationalize the Skaguay Wharf and the Road to the Cana-dian Frontier at the White Pass.

WASHINGTON, May 20,-A dispatch sent from here last night to a New York newspaper regarding the Alaska boundary made it appear that the matter has assumed a serious aspect. Great Britain was represented as entering strenuous objections to the war department sending troops to Alaska at this time.

Officials of both the war and state departments today pronounced the dispatch sensational and untrue. Negotiations respecting the boundary are proceeding in London. This government made a proposition which was rejected by England. A counter proposal was then made, which was rejected by this government. Negotiations are now in progress for what both parties hope will, be a satisfactory compromise.

When it was seen that it might be some time before a modus vivendi could be agreed upon, the war department, at the suggestion of the state department, decided to send troops in order to prevent those serious disturbances which Gov. Brady and others had reported would be inevitable were not the overawing strong arm of martial law plainly

visible. What the British government did was to very mildly suggest that it would be inadvisable for either government to largely increase its military force in the disputed territory, as it might create an impression that forcible occupation was intended. The state department has assured the British authorities that it has no intention of permanent military occupation, although distinctly declaring that it reserves to itself the right to take every necessary means to preserve order and uphold the law. This has been accepted as quite satisfactory by the British government, and that is all there is to the sensation. LONDON, May 20 .- The fate of the Anglo-American-Canadian commission is naturally regarded here as a matter of great importance, and the various rumors and reports on the subject attract much attention. A dispatch from Washington to the effect that the resumption of the commission's labor depends upon a settlement of the Alaskan boundary dispute has been published in this city.

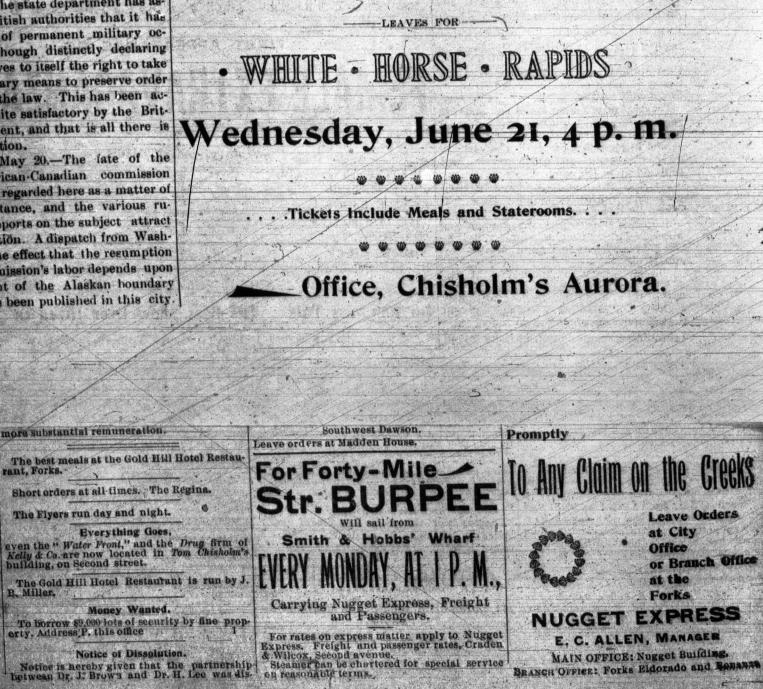
