CALL FOR INTRODUCTION OF NEW BUDGETARY MEASURES— MOTION UNDER S.O. 43

POLAND—CONDEMNATION OF MILITARY GOVERNMENT— MOTION UNDER S.O. 43

That this House soundly condemn the military Government of Poland, and its Russian masters, for denying the Polish people their right to freedom of choice, and for the use of force and violence to crush the Solidarity movement, and warn

the Soviet Union of serious consequences if it continues to interfere in the domestic affairs of Poland.

CONGRATULATIONS TO NEW SECRETARY GENERAL, JAVIER PEREZ DE CUELLAR—MOTION UNDER S.O. 43

Mr. Marcel Prud'homme (Saint-Denis): Madam Speaker, pursuant to Standing Order 43 I move, seconded by the hon. member for Parry Sound-Muskoka (Mr. Darling) and the hon. member for Hamilton Mountain (Mr. Deans):

That the House of Commons express its warmest congratulations to the new Secretary General of the United Nations, the Peruvian, Javier Perez de Cuellar, who has been elected unanimously by the General Assembly of the United Nations as the fifth Secretary General of that organization, and the first from our own western hemisphere; and that the House of Commons express its appreciation and thanks to the outgoing Secretary General Kurt Waldheim for his untiring efforts for peace during his two mandates as Secretary General from 1971 to 1981.
