VANCOUVER AIRPORT—WORKING CONDITIONS OF IMMIGRATION OFFICIALS

Mr. Bob Kaplan (York Centre): Mr. Speaker, in the absence of the Minister of Employment and Immigration and his parliamentary secretary, I will direct the question to the acting minister. In this House last Friday, I asked the Minister of Employment and Immigration about a grievance of the immigration officials working at the Vancouver airport—a serious matter which they raised about their pay and their workload. The minister said he knew absolutely nothing about it and indicated he would look into it.

In the meanwhile, the union has brought to my attention a letter from the Postmaster General's office saying that the Minister of Employment and Immigration did know about the matter, that he had received complaints from many parliamentarians and that the concerns were known to him. I would ask the minister to ask his colleague to get his act together, to look into this matter and to do something about the problem that has been raised.

Hon. Lincoln M. Alexander (Minister of Labour): Mr. Speaker, there is no doubt that the question raised the other day by the hon. member is, of course, important. I note that he is concerned again as a result of having further information which indicates that the Minister of Employment and Immigration did know of the particular circumstances involved. All I can say is that I will take notice of the hon. member's question and bring it to the attention of the minister just as soon as I can, in order that this matter can be looked into.
