## **MOTION UNDER S.O. 31**

CANADIAN PARTICIPATION IN SDI RESEARCH

Mr. Speaker: I am in receipt of a notice of motion from the Hon. Member for New Westminster-Coquitlam (Ms. Jewett) under Standing Order 31.

Ms. Pauline Jewett (New Westminster-Coquitlam): Mr. Speaker, in accordance with Standing Order 31, I ask leave to move that this House do now adjourn for the purpose of debating an extremely urgent and important matter, namely, the undermining of Canada's national interest by various Ministers offering assistance to Canadian companies that wish to take part in star wars research, when the Prime Minister (Mr. Mulroney) clearly said on September 7 that participation would not be in Canada's interest.

If leave is granted, we in this Party will present the serious concerns of Canadians on this matter and will impress upon the Government the danger to Canada's national and international interests of any involvement in the Strategic Defence Initiative.

Mr. Speaker: The Hon. Member for New Westminster-Coquitlam has given the Chair the required notice of her intention to seek leave of the House to move a motion to adjourn.

While I appreciate that the matter she has raised is one in which she has a particular interest, as do many Hon. Members of the House, and is one of continuing interest to the House, I have been unable to find in her submission the elements of a genuine emergency. Consequently I cannot justify ruling in favour of an emergency debate.

Furthermore, to be consistent with the ruling that I gave earlier this week, I should remind the Hon. Member that the first report of the Special Joint Committee on International Relations is currently before the House and she may find

therein a method to have a debate on the matter at some early moment.
