**LATEST THEORY IS THAT FRANK HALL LIVED IN HAMILTON**

**Mystery Veteran Recognizes Resident of Hamilton.**

HAMILTON, April 8.—There is reason to believe that Frank Hall, the unidentified soldier, lived in Hamilton during the year 1912. Yesterday R. Robinson, 38 Oak avenue, visited the soldier, hoping that he might be his brother, Richard Robinson, who was reported missing while with the 4th C. M. R. Hall recognized Robinson, as a Hamilton man as soon as he walked into the ward, and told him that he worked for the Canadian Westinghouse in September, 1912.

He also remembered having boarded with people whose name began with "W.", and who lived near the police magistrate's home. The unfortunate man struggled to find a connection with Christ Church Cathedral, claiming that it was Dean Abbott who secured employment for him with the Westinghouse. Hall asked Robinson if he knew a Jack Raymond who had worked for the Otis Elevator Company, and who lived on Simcoe street east. Raymond is said to have been engaged to Hall's sister. Inquiries at the local factories mentioned brought forth the information that they had no record of Hall or Raymond.

The theory that Hall might prove to be a Hamilton soldier named Perovits is exploded. The latter was reported missing in 1916, whereas Hall remembers the battles up to and including Passchendaele in 1918.

## CRITICISM OF FRANCHISE BILL DELAYS ACTION

Peterboro Member Would Prevent Farmers' Campaign Collection.

**EMPLOYEES TO VOTE**  
Employers Must Allow Hours Other Than Noon Hour For Polling.

OTTAWA, April 8.—(By the Canadian Press).—Discussion of the franchise bill in the House of Commons today followed consideration of such varied topics as inspection of fish, civil service insurance, certificates for master mariners, and a bill to carry the franchise bill into effect. The franchise bill was again in committee. Presumably non-contentious clauses were under consideration, but so constant was the stream of bantering criticism that comparatively few clauses were passed.

Hugh Guthrie, solicitor-general, termed the ancient and honorable office of the clerk of the crown in chancery, an office which dates back in Canadian history to the time of the first settlement. The magistrate threw all the cases out, insisting that the evidence of the spotters must be corroborated. Judge Gould held that this was not necessary. 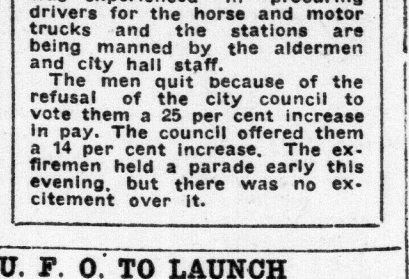

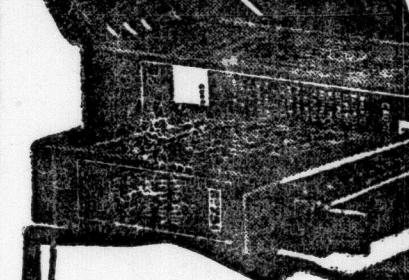

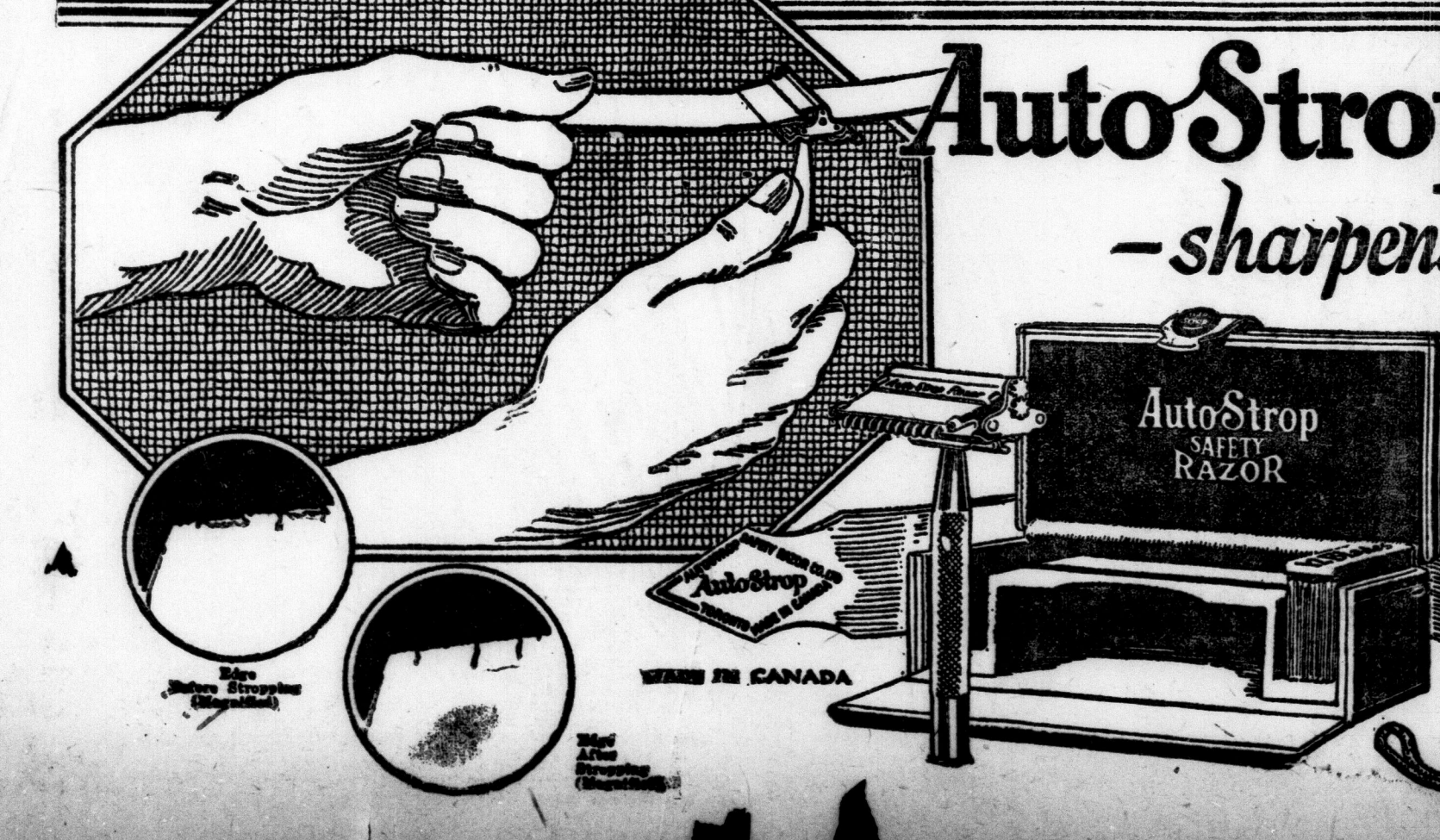
