William Wyndham, who has recently become the head of the British consulate in this city, yesterday presented to Michael Cummins a medal awarded him by the British government in recognition of his bravery in rescuing the crew of the British schooner Griqualand, near the Bay of Fundy, Jan. 22, 1903.
