Submarine Murders Some More Women

Belgian Steamer Sunk With 17 People, Including Captain's Wife and Daughter-Three Norwegian Vessels Sent to Bottom.

London, June 8-12:30 p.m.-The Belgian steamer Menapier has been sent to the bottom by a German torpedo near the North Foreland. Out of 23 persons on board, only 6 were saved. The captain, his wife and his daughter, the first mate and the pilot and twelve memhers of the crew lost their lives.

The Belgian steamer Menapier was of 1,425 net tons, and was 281 feet long. She was built in Sunderland in 1908, and was owned in Antwerp.

The Signal believes that the principle of public owner-ship is as sound as ever; but it has been injured in reputation by being pushed too recklessly. The hydro-electric movement in Ontario is a case in point. 
