## LABOUR CONDITIONS

ATLANTIC PROVINCES—INCREASE IN RATE OF UNEMPLOYMENT

On the orders of the day:

Mr. H. Russell MacEwan (Pictou): Mr. Speaker, I have a question for the Minister of Labour. I want to ask the Minister when he expects to commence the war on poverty in the Atlantic Provinces, in view of the fact that the unemployment rate for April of this year was 12.8 per cent, and having regard to the fact that in March it was 12.5 per cent, and 12.3 per cent in April of last year.

Hon. A. J. MacEachen (Minister of Labour): Mr. Speaker, the unemployment rate, of course, in the Atlantic Provinces is too high. It is much less than it was under the administration supported by my hon. friend.

Some hon. Members: Oh, oh.

## REQUEST FOR ANNOUNCEMENT OF DESIGNATED AREAS

On the orders of the day:

Mr. John Mullally (Kings): I should like to ask the Minister of Industry if he can advise us when the Government will announce new designated areas for special economic assistance, as well as changes in the types of incentive that will be provided.

Hon. C. M. Drury (Minister of Industry): I think all hon. Members will be interested in this question. The House is fully aware of the intensive drive being made by the Government to provide adequate opportunity for some of the less favoured areas of Canada. A new scheme for designated areas changing the incentives is being co-ordinated now with a general program. It would be my hope that in the near future an announcement could be made.

Mr. Muir (Cape Breton North and Victoria): May I ask a supplementary question.

Mr. Speaker: I must take one at a time. At the moment there are at least four hon. Members pressing supplementary questions. The first supplementary should go to the Whip of the Opposition, the hon. Member for Grey-Bruce.

Mr. Eric A. Winkler (Grey-Bruce): I should like to ask the Minister if he will keep in mind my suggestion of some weeks ago that he considered the entire Georgian Bay area as a designated area. I should like him to take this into consideration when the new terms are made public.

Mr. Drury: Yes, Mr. Speaker.

Mr. Robert Muir (Cape Breton North and Victoria): May I ask the Minister, in answer to the many requests he has undoubtedly
