Right Hon. P. E. Trudeau (Prime Minister): I shall confer with the Minister of National Health and Welfare on this, Mr. Speaker.

Mr. Paproski: In light of the fact that the social development council only received \$995,000 in the 1970-71 budget to monitor and research that \$7 billion, can the Prime Minister assure the House that far greater funds will be made available next year and, if so, will a statement be made shortly?

Mr. Speaker: While the matter is being considered—the hon. member, of course, is making a suggestion and he has to assume that it will be considered.

Mr. Paproski: One further supplementary.
